THE CITY OF SOUTHAMPTON (OXFORD STREET) (PROHIBITION OF MOTOR VEHICLES) ORDER 2018

Southampton City Council in exercise of its powers under Section 1 and 2, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION AND COMMENCEMENT

1 This Order shall come into operation on 19 January 2018 and may be cited as The City of Southampton (Oxford Street) (Prohibition of Motor Vehicles) Order 2018.

INTERPRETATION

- 2 In this Order:
 - "Principal Order No 1" shall mean the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
 - (ii) "Principal Order No 2" shall mean the City of Southampton (First Controlled Zone) Order 2012, as amended
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - Any reference to an enactment shall be construed as a reference to that enactment as (iv) amended by any subsequent enactments.


