



**THE CITY OF SOUTHAMPTON (RESIDENTS PARKING) (ZONES 1-12 & 16)
(AMENDMENT 16) (PART 1) ORDER 2018**

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on 19th June 2019 and may be cited as The City of Southampton (Residents' Parking) (Zones 1-12 & 16) (Amendment 16) (Part 1) Order 2018.

INTERPRETATION

- 2 In this Order:
- (i) "Principal Order" means The City of Southampton (Residents Parking) (Zones 1-12 & 16) Order 2014, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3 The contents of Schedule 1 shall be added to Schedule 2.0.1 to the Principal Order
- 4 The contents of Schedule 2 shall be deleted from Schedule 2.0.1 to the Principal Order

Road	Side	Description	Zone
Bracken Lane (Spine)	South	From 1 metre west of the western boundary of 7 Bracken Lane westwards to its junction with Chalfont Court	7
Bracken Lane (Spine)	South	From the western kerbline of Holland Place westwards to 4 metres southwest of the boundary between 1/3 Bracken Lane	7
Bracken Lane (spur leading to Nos 15-69)	East	For its entire length including the closed-end	7
Bracken Lane (spur leading to Nos 15-69)	North	For the entire length of the adopted highway	7
Bracken Lane (spur leading to Nos 15-69)	West	From the northern kerbline of Bracken Lane (spur leading to Nos 15-69) northwards for 5m	7
