

THE CITY OF SOUTHAMPTON (RESIDENTS PARKING) (ZONES 1–12 & 16) (AMENDMENT 18) ORDER 2018

Southampton City Council in exercise of its powers under Sections 1, 2, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 1st April 2019 and may be cited as The City of Southampton (Residents Parking) (Zones 1–12 & 16) (Amendment 18) Order 2018.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order" shall mean The City of Southampton (Residents Parking) (Zones 1– 12 & 16) Order 2014, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

ADDITION/AMENDMENT OF SCHEDULES

- 3 The contents of schedule 1 shall be added to schedule 2.0.1 to the Principal Order.
- 4 The contents of Schedule 2 shall be deleted from Schedule 2.0.1 to the Principal Order
- 5 The contents of schedule 3 shall be added to schedule 3.0.1 to the Principal Order.
- 6 The contents of Schedule 4 shall be deleted from Schedule 3.0.1 to the Principal Order
- 7 The contents of Schedule 5 shall be added to Schedule 5.3.1 to the Principal Order
- 8 The contents of Schedule 6 shall be deleted from Schedule 5.3.1 to the Principal Order
- 9 The contents of Schedule 7 shall be deleted from Schedule 8.0.8 to the Principal Order
