

### THE CITY OF SOUTHAMPTON (SCN3 NORTHAM CYCLE SCHEME) ORDER 2020

Southampton City Council in exercise of its powers under Sections 1, 2, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

### CITATION AND COMMENCEMENT

1 This Order shall come into operation on 14<sup>th</sup> September 2020 and may be cited as The City of Southampton (SCN3 Northam Cycle Scheme) Order 2020.

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order 1" shall mean The City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010.
  - (ii) "Principal Order 2" shall mean The City of Southampton (Bus Lanes, Bus-Only Streets and Bus Gates) Order 2017.
  - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.


### **AMENDMENTS**

- 6 The contents of Schedule 4 shall be added to Schedule 1 of Principal Order 2.
