



THE CITY OF SOUTHAMPTON
(FIRST CONTROLLED ZONE) (AMENDMENT NO 5)
TRAFFIC REGULATION ORDER 2010

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 45, 46, 49 and 53 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:

1 Citation and Commencement

This Order shall come into operation on 22 October 2010 and may be cited as the City of Southampton (First Controlled Zone) (Amendment No 5) Traffic Regulation Order 2010.

2 Interpretation

- (a) In this Order "the Principal Order" means the City of Southampton (First Controlled Zone) Traffic Regulation Order 2008, as amended.
- (b) The definition of "Restricted Hours" in Article 2(A) of the Principal Order shall be deleted and replaced with the following:-
"Restricted Hours" means:-
 - (i) in relation to any restricted road specified in Schedules 2.02, 3.08, 7.01, 8.01, 8.02, 8.03 or 8.04 the period between 8.00 am and 6.00 pm on Monday to Saturday and on Sundays, Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be allowed) between Noon and 6:00 pm;
 - (ii) in relation to any restricted road specified in Schedules 2.01, 7.02, 7.04 and 7.11 the whole twenty four hours of every day; and
 - (iii) in relation to any restricted road specified in Schedule 2.19, the period between 10.00 am and 11.00 am on any day other than a Sunday.
- (c) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (d) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

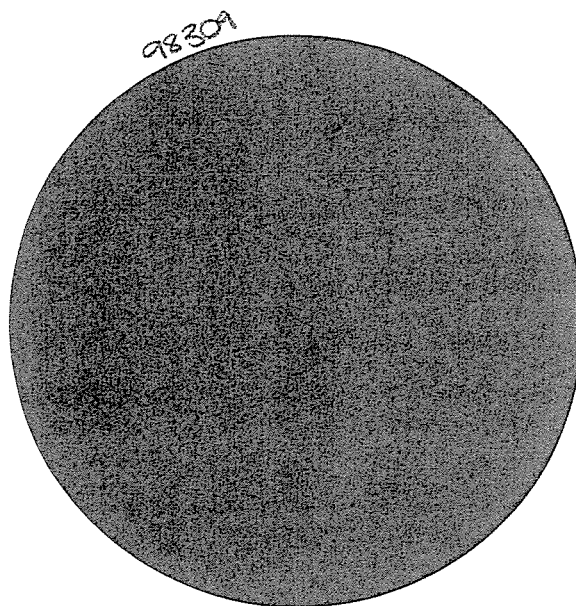
3 Waiting Restrictions

- (a) The contents of Schedule 1 shall be inserted into Schedule 2.01 to the Principal Order.
- (b) The contents of Schedule 2 shall be deleted from Schedule 2.02 to the Principal Order.
- (c) The contents of Schedule 3 shall be inserted into Schedule 2.02 to the Principal Order.

- (d) The contents of Schedule 4 shall be added to the Principal Order as a new Schedule 2.19.
- (e) The contents of Schedule 5 shall be deleted from Schedule 7.01 to the Principal Order.
- (f) The contents of Schedule 6 shall be inserted into Schedule 7.01 to the Principal Order.

Schedule 1: No Waiting at Any Time (addition)

Road	Side	Description
Commercial Road	North	From a point 14.5m west of the eastern kerb-line of West Marlands Road westwards for 4m

Schedule 2: No Waiting Monday-Saturday 8am-6pm, Sunday 12 Noon-6pm (deletion)

Road	Side	Description
White Star Place	All	For their entire length

Schedule 3: No Waiting Monday-Saturday 8am-6pm, Sunday 12 Noon-6pm (addition)

Road	Side	Description
White Star Place	Both	From the western kerb-line of Carpathia Drive westwards for 13m

Schedule 4: No Waiting Monday-Saturday 10am-11am (addition)

Road	Side	Description
White Star Place	All	From a point 13m west of the western kerb-line of Carpathia Drive westwards and northwards to the western and northern closed ends of White Star Place

Schedule 5: Motor Cycle Parking Bays (deletion)

Road	Side	Description
Commercial Road	North	From a point 3.5m west of the eastern kerb-line of West Marlands Road westwards for 15m

Schedule 6: Motor Cycle Parking Bays (addition)

Road	Side	Description
Commercial Road	North	From a point 3.5m west of the eastern kerb-line of West Marlands Road westwards for 11m
