



**THE CITY OF SOUTHAMPTON
(FIRST CONTROLLED ZONE) (AMENDMENT NO 4)
TRAFFIC REGULATION ORDER 2011**

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 45, 46, 49 and 53 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:

1 CITATION

This Order shall come into operation on 01 July 2011 and may be cited as the City of Southampton (First Controlled Zone) (Amendment No 4 Traffic Regulation Order 2011).

2 INTERPRETATION

- (i) In this Order the "Principal Order" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2008, as amended.
- (ii) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (iii) Any reference in this Order to any enactment shall be construed as a reference to that enactment, as amended by any subsequent enactment.
- (iv) The prohibitions, restrictions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.

3 WAITING RESTRICTIONS

- (a) In Article 2A of the Principal Order the definition for "Restricted Hours" shall be deleted and replaced with the following:-

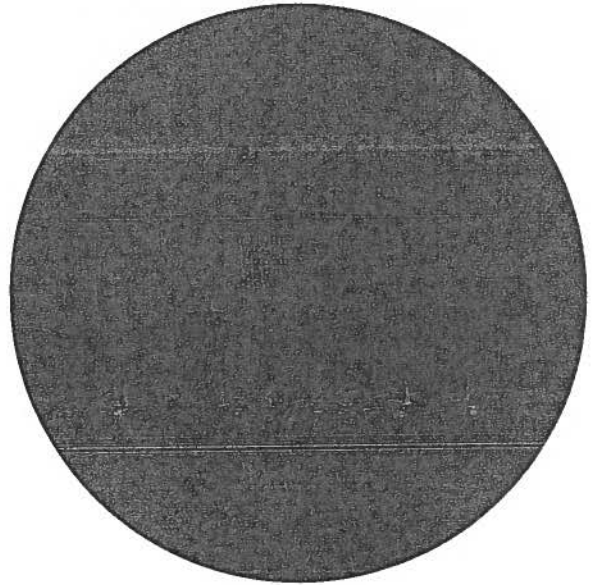
"Restricted Hours" means:

- (i) in relation to any restricted road specified in Schedules 2.02, 3.08, 7.01, 8.01, 8.02, 8.03 or 8.04 the period between 8.00 am and 6.00 pm on Monday to Saturday and on Sundays, Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be allowed) between 12 noon and 6:00pm; and
 - (ii) in relation to any restricted road specified in Schedules 2.01, 2.18, 7.02, 7.04 and 7.11 the whole twenty four hours of every day.
- (b) The contents of Schedule 1 shall be inserted into Schedule 2.01 of the Principal Order.
- (c) The contents of Schedule 2 shall be inserted into new Schedule 2.18 to the Principal Order.
- (d) The contents of Schedule 3 shall be inserted into Schedule 7.11 to the Principal Order.

- (e) The contents of Schedule 4 shall be deleted from Schedule 8.01 to the Principle Order.
- (f) The contents of Schedule 5 shall be inserted into Schedule 8.01 to the Principle Order.

Schedule 1: No Waiting at Any Time (addition)

Road	Side	Description
Palmerston Road	East	From a point 146m south of the southern kerb-line of South Front southwards for 3m

Schedule 2: No Waiting Midnight to 6am (addition)

Road	Side	Description
South Front	West	From 14m east of the eastern kerb-line of Palmerston Road eastwards to a point 150m west of the western kerb-line of Kingsway

Schedule 3: Bus Parking Places, with 10 Hour Limit, No Return Same Day (addition)

Road	Side	Description
Palmerston Road	East	From a point 116m south of the southern kerb-line of South Front southwards for 30m (width 3m)

Schedule 4: Parking Places – Central Core – Red Code (deletion)

Road	Side	Description
Palmerston Road	East	From a point 39m south of the southern kerb-line of South Front southwards for 109m (max. 20 bays)

Schedule 5: Parking Places – Central Core – Red Code (addition)

Road	Side	Description
Palmerston Road	East	From a point 39m south of the southern kerb-line of South Front southwards for 77m (max. 14 bays)
