THE CITY OF SOUTHAMPTON (OXFORD STREET)

TRAFFIC REGULATION ORDER 2012

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 32(1), and 35(1) and (3), 45, 46 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1 Citation and Commencement

This Order shall come into operation on 23 January 2012 and may be cited as the City of Southampton (Oxford Street) Traffic Regulation Order 2012.

2 Interpretation

- (a) In this Order "Principal Order No 1" means the City of Southampton (First Controlled Zone) Order 2008, as amended.
- (b) In this Order "Principal Order No 2" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
- (c) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (d) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- 3 In Article 4 of Principal Order No 1 "Nothing in Articles 4 or 30" shall be deleted and replaced with "Nothing in Articles 3 or 30".

4 No Unloading/Unloading

In Article 8 of Principal Order No 1 new sub-paragraph (ix) shall be inserted as follows:

"in such part of a restricted road as is specified in Schedule 3.14 during the period between the hours of 11am and 12:00 Midnight and during the period between the hours of 12:00 Midnight and 6am".

5 Waiting Restrictions

- (a) The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order No 1.
- (b) The contents of Schedule 2 shall be deleted from Schedule 2.02 to the Principal Order No 1.

- (c) The contents of Schedule 3 shall be deleted from Schedule 8.02 to the Principal Order No 1.
- (d) The contents of Schedule 4 shall be inserted into Schedule 2.01 to the Principal Order No 1.
- (e) The contents of Schedule 5 shall be added as a new Schedule 3.14 to the Principal Order No 1.
- (f) The contents of Schedule 6 shall be inserted into Schedule 8.02 to the Principal Order No 1.
- (g) The contents of Schedule 7 shall be inserted into Schedule 8.05 to the Principal Order No 2.



John Street	East	From the northern kerb-line of Oxford Street northwards for 12m
John Street	East	From a point 22m north of the northern kerb-line of Oxford Street northwards for 21m
John Street	East	From the southern kerb-line of Bernard Street to a point 75m north of the northern kerb-line of Oxford Street
Oxford Street	North	From a point 10m west of the western kerb-line of John Street eastwards to a point 10m east of the eastern kerb-line of John Street

Schedule 2: No Waiting Monday-Saturday 8am-6pm, Sunday 12 Noon-6pm (deletion)

Road	Side	Description
Latimer Street	East	From the northern kerb-line of Oxford Street northwards to a point 22m south of the northern flank wall of 9 Latimer Street
Oxford Street	North	From a point 34m east of the eastern kerb-line of John Street eastwards to the eastern closed end of Oxford Street
Oxford Street	North	From a point 18m east of the eastern kerb-line of Latimer Street eastwards to a point 10m west of the western kerb-line of John Street
Oxford Street	North	From a point 10m east of the eastern kerb-line of John Street eastwards for 8m
Oxford Street	North	From the eastern kerb-line of Latimer Street eastwards for 8m
Oxford Street	South	From a point 38m east of the extended eastern kerb-line of John Street eastwards to the eastern closed end of Oxford Street
Oxford Street	South	From a point 19m east of the eastern kerb-line of Latimer Street eastwards to the extended eastern kerb-line of John Street
Oxford Street	South	From the eastern kerb-line of Latimer Street eastwards for 9m

John Street	East	From a point 12m north of the northern kerb-line of Oxford Street northwards for 10m (max. 2 bays)
John Street	East	From a point 43m north of the northern kerb-line of Oxford Street northwards for 32m (max. 6 bays)
Oxford Street	South	From a point 9m east of the eastern kerb-line of Latimer Street eastwards for 10m (max. 2 bays)
Oxford Street	South	From the extended eastern kerb-line of John Street eastwards for 38m (max. 7 bays)
Oxford Street	North	From a point 8m east of the eastern kerb-line of Latimer Street eastwards for 10m (max. 2 bays)
Oxford Street	North	From a point 18m east of the eastern kerb-line of John Street eastwards for 16m (max. 3 bays)
