

THE CITY OF SOUTHAMPTON (SEA CITY) TRAFFIC REGULATION ORDER 2012

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 9, 10(1) and (2), 32(1) and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1 Citation and Commencement

This Order shall come into operation on 31st March 2012 and may be cited as the City of Southampton (Sea City) Traffic Regulation Order 2012.

2 Interpretation

- (1) In this Order, except where the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them:
 - "Principal Order No 1" shall mean City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended;
 - "Principal Order No 2" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended;
 - "Principal Order No 3" shall mean The City of Southampton (First Controlled Zone) Traffic Regulation Order 2008, as amended;
- (2) "Enactment" shall include any subordinate legislation within the meaning of the Interpretation Act 1978;
- (3) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (4) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

3 Movement Restrictions

- (1) The contents of Schedule 1 to this Order shall be deleted from Schedule 1 to Principal Order No 1.
- (2) The contents of Schedule 2 to this order shall be deleted from Schedule 18 to Principal Order No 1.
- (3) The contents of Schedule 3 to this Order shall be added to Schedule 14 to Principal Order No 1.
- (4) The contents of Schedule 4 to this Order shall be deleted from Schedule 14 to Principal Order No 1.
- (5) The contents of Schedule 5 to this Order shall be added to Schedule 24 to Principal Order No 1.

4 Waiting Restrictions

The following shall be inserted as a new Paragraph 5H to Principal Order No 2:

"Save as provided in Article 7(i) and (iv), no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit:

- (i) any vehicle other than a bus to wait between the hours of 8.00am to 6.00pm, Monday to Sunday in the parking places specified in Schedule 7.12
- (ii) any bus to wait between the hours of 8.00am to 6.00pm, Monday to Sunday, for a longer period than 30 minutes or if a period of less than 30 minutes has elapsed since the termination during the said hours of the last period of waiting of the vehicle (if any) in the parking places specified in Schedule 7.12:"
- (6) The contents of Schedule 6 to this Order shall be added as a new Schedule 7.12 to Principal Order No 2.
- (7) The contents of Schedule 7 to this Order shall be added to Schedule 5.13 to Principal Order No 2.
- (8) The contents of Schedule 8 to this Order shall be deleted from Schedule 5.13 to Principal Order No 2.
- (9) The contents of Schedule 9 to this Order shall be deleted from Schedule 2.01 to Principal Order No 3.
- (10) The contents of Schedule 10 to this Order shall be added to Schedule 2.01 to Principal Order No 3.
- (11) The contents of Schedule 11 to this Order shall be added to Schedule 7.01 to Principal Order No 3.
- (12) The contents of Schedule 12 to this Order shall be deleted from Schedule 7.01 to Principal Order No 3.
- (13) The contents of Schedule 13 to this Order shall be deleted from Schedule 8.01 to Principal Order No 3.
