

THE CITY OF SOUTHAMPTON (FIRST CONTROLLED ZONE) TRAFFIC REGULATION ORDER (AMENDMENT NO 5) ORDER 2012

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 45, 46, 47, 48, 49 and 53 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:

1 CITATION

This Order shall come into operation on 30th March 2012 and may be cited as the City of Southampton (First Controlled Zone) Traffic Regulation Order (Amendment No 5) Order 2012.

2 INTERPRETATION

- (1) In this Order the "Principal Order" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2008, as amended.
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment, as amended by any subsequent enactment.

The prohibitions, restrictions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.

3 **RESTRICTIONS**

(1) In Article 2A of the Principal Order the definition for "Permitted Hours" paragraph will be replaced with the following contents:-

"Permitted Hours" means in so far as it relates to those parking places in Schedules 8.01, 8.02, 8.03 and 8.04 between 8.00 am and 6.00 pm on Monday to Saturday and on Sundays, between 1pm and 6:00 pm; including Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be free).

(2) In Article 2A of the Principal Order the definition for "Restricted Hours" will be replaced with the following contents:-

"Restricted Hours" means:

- (a) in relation to any restricted road specified in Schedules 2.02, 8.01, 8.02, 8.03 or 8.04 the period between 8.00 am and 6.00 pm on Monday to Saturday and on Sundays, between 1pm and 6:00 pm; including Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be free); and
- (b) in relation to any restricted road specified in Schedules 2.01, 2.14, 3.01, 7.01, 7.02, 7.04, 7.07 and 7.11 the whole twenty four hours of every day; and


- (c) in relation to any restricted road specified in Schedule 2.18 from Midnight to 6am every day; and
- (d) in relation to any restricted road specified in Schedules 3.07 and 3.08 from 8am to 6pm every day; and
- (e) in relation to any restricted road specified in Schedule 3.03 from 8am to 9.30am and 4.30 to 6pm every day; and
- (f) in relation to any restricted road specified in Schedule 3.05 from 7am to 7pm every day; and
- (g) in relation to any restricted road specified in Schedule 3.06 from 8.00am to 9.30pm, 12.00pm to 3.00pm, and 4.30pm to 6.30pm every day.
- (3) In the List of Schedules and for the title of Schedule 2.02 in the Principal Order the following description for Schedule 2.02 will now apply:-

"No Waiting Monday - Saturday 8am - 6pm, Sunday 1pm - 6pm"

- (4) The contents of Schedule 1 will be deleted from Schedule 2.01 of the Principal Order
- (5) The contents of Schedule 2 will be added to Schedule 2.01 of the Principal Order
- (6) The contents of Schedule 3 will be deleted from Schedule 2.02 of the Principal Order
- (7) The contents of Schedule 4 will be added to Schedule 2.02 of the Principal Order
- (8) The contents of Schedule 5 will be added to Schedule 7.01 of the Principal Order
- (9) The contents of Schedule 6 will be deleted from Schedule 8.02 of the Principal Order
- (10) The contents of Schedule 7 will be added to Schedule 8.02 of the Principal Order






