

THE CITY OF SOUTHAMPTON (FIRST CONTROLLED ZONE) (AMENDMENT NO 6) TRAFFIC REGULATION ORDER 2012

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), 45, 46, 47, 48, 49 and 53 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:.

1 CITATION

This Order shall come into operation on Friday 27th April 2012 and may be cited as the City of Southampton (First Controlled Zone) (Amendment No 6) Traffic Regulation Order 2012.

2 INTERPRETATION

- (1) In this Order the "Principal Order" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2008, as amended.
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) Any reference in this Order to any enactment shall be construed as a reference to that enactment, as amended by any subsequent enactment.
- (4) The prohibitions, restrictions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.

3 **RESTRICTIONS**

- (1) New schedule 8.05: "Parking Places Outer Area Grey Code" shall be added to the List of Schedules in the Principal Order
- (2) In Article 2A of the Principal Order the definition for "Permitted Hours" shall be substituted with the following:

"Permitted Hours" means insofar as it relates to those parking places in Schedules 8.01, 8.02, 8.03, 8.04 and 8.05 between 8.00am and 6.00pm on Monday to Saturday and on Sundays, between 1pm and 6:00 pm; including Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be free).

(3) In Article 2A of the Principal Order paragraph (i) of the definition for "Restricted Hours" shall be substituted with the following:-

"in relation to any restricted road specified in Schedules 2.02, 8.01, 8.02, 8.03, 8.04 or 8.05 the period between 8.00am and 6.00pm on Monday to Saturday and on Sundays, between 1pm and 6:00 pm; including Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be free); and"

(4) The contents of Article 11 of the Principal Order shall be substituted with the following:-

"Each area on the carriageway of a highway in the City of Southampton which is bounded on the side shown in column 2 of Schedules 8.01, 8.02, 8.03 8.04 and 8.05 by so much of the edge of the carriageway as is shown in column 3 of those Schedules and which extends throughout for a width of 2m from the edge of the carriageway or as otherwise shown in column 3 of those Schedules is hereby designated as a parking place for the purposes of this Order"


(5) The contents of Article 12 of the Principal Order shall be substituted with the following

"The number of parking bays in each parking place shall not exceed the number specified in column 3 of Schedules 8.01, 8.02, 8.03 8.04 and 8.05 in relation to that parking place, and the number and situation of such parking bays in each parking place shall be as may be determined by the Council"

- (6) The contents of Schedule 1 shall replace the contents of Schedule 1.05 to the Principal Order.
- (7) The contents of Schedule 2 shall be deleted from Schedule 2.02 to the Principal Order.
- (8) The contents of Schedule 3 shall be inserted into Schedule 2.02 to the Principal Order.
- (9) The contents of Schedule 4 shall be deleted from Part 1 of Schedule 8.03 to the Principal Order.
- (10) The contents of Schedule 5 shall be added as a new Schedule 8.05 to the Principal Order.
