



THE CITY OF SOUTHAMPTON (CENTENARY QUAY) TRAFFIC REGULATION AND SPEED LIMIT ORDER 2012

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 9, 10(1) and (2), 32(1) and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1 Citation and Commencement

This Order shall come into operation on 25 May 2012 and may be cited as the City of Southampton (Centenary Quay) Traffic Regulation Order 2012.

2 Interpretation

(a) In this Order, except where the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them:

"Principal Order No 1" shall mean City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended;

"Principal Order No 2" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended;

"Principal Order No 3" shall mean The City of Southampton (Woolston) (Residents' Parking Scheme) Traffic Regulation Order 2010, as amended;

"Principal Speed Limit Order" shall mean The City of Southampton (Various Roads) (Speed Limits) (No 1) Order 2011 as amended

(b) "Enactment" shall include any subordinate legislation within the meaning of the Interpretation Act 1978;

(c) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

(d) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

3 (i) The following paragraph shall be inserted as a new Article 5A to Principal Order No 3:

Any person whose usual place of abode is at premises the postal address of which is

who:

- (a) Is the owner of a vehicle of the following class, that is to say a passenger vehicle, a goods vehicle or a motor cycle, or
- (b) with the permission of the owner uses a vehicle of the said class on a regular basis during the course of his employment,

may apply to the Council for the issue of a residents' permit for the leaving of that vehicle and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied. A maximum of one permit is available per postal address in respect of the above addresses. There shall be no entitlement to Visitor Parking Permits, business permits or temporary business permits in respect of the above addresses.

- 4 Paragraph (i) of Article 9 to Principal Order No 3 shall be deleted and replaced with the following

CHARGES FOR PERMITS

- i) (a) save as provided in (b) below, there shall be no charge for the issue of a resident's permit by the Council provided that at the time of issue of the permit no other resident at the applicant's postal address already holds a permit issued free of charge under the terms of this paragraph.
- (b) in respect of those properties detailed in Article 5A, The charge for the issue by the Council of a Resident's permit having a validity of 1 year shall be £150.
- (c) when a permit issued under the provisions of paragraph (b) above is surrendered in accordance with Article 10 the Council shall pay to the permit holder in respect of each complete unexpired calendar month for which the permit would have been valid a refund of £12.00
- (d) in respect of the properties detailed in Article 5A, the charge for a temporary permit having a validity of one month will be £12.50.

5 Movement Restrictions

- (a) The contents of Schedule 1 to this Order shall be added to Schedule 14 to Principal Order No 1.
- (b) The contents of Schedule 2 to this Order shall be added to Schedule 39 to Principal Order No 1.
- (c) The contents of Schedule 3 to this Order shall be added to Schedule 12 to Principal Order No 1.

6 Speed Limits

- (a) The contents of Schedule 4 to this Order shall be added to Schedule 11.01 to the Principal Speed Limit Order.

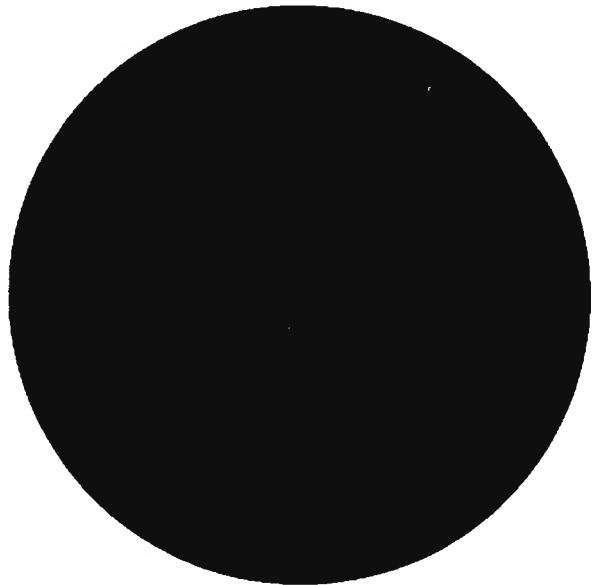
