

#### THE CITY OF SOUTHAMPTON

## (VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT NO. 8) TRAFFIC REGULATION ORDER 2012

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 32(1), and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

#### 1. CITATION

This Order shall come into operation on 5<sup>th</sup> November 2012 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment No. 8) Traffic Regulation Order 2012.

#### 2. INTERPRETATION

- i) In this Order, except where the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them:
  - a) "Principal Order No 1" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended
  - b) "Principal Order No 2" shall mean City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended
- *ii)* Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- iii) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

#### 3. PROHIBITION OF WAITING

The following will be inserted as a new paragraph xiii in Article 3 of the Principal Traffic Order:

"between the hours of 8.00am - 4.00pm, Monday to Friday in the lengths of road or on the side of the roads specified in Schedule 2.21".

#### 4. WAITING RESTRICTIONS


- i) The contents of Schedule 1 shall be deleted from Schedule 2.01 to Principal Order No 1.

- iii) The contents of Schedule 3 shall be deleted from Schedule 2.03 to Principal Order No 1.
- iv) The contents of Schedule 4 shall be inserted into Schedule 2.03 to Principal Order No 1.
- v) The contents of Schedule 5 shall be added as a new Schedule 2.21 to Principal Order No 1.
- vi) The contents of Schedule 6 shall be deleted from Schedule 6.01 to Principal Order No 1.


- vii) The contents of Schedule 7 shall be inserted into Schedule 6.01 to Principal Order No 1.
- viii) The appearance of the road name "Queensway" in schedules 4.01, 4.02 and 8.05 to Principal Order No 1 shall be replaced with "Queen's Way".
- *ix)* The appearance of the road name "Queensway" in schedules 2.01, 2.02, 3.07, 8.01 and 8.02 to Principal Order No 2 shall be replaced with "Queen's Way"
- x) The appearance of the road name "Queensway Service Road" in Schedule 2.01 Principal Order No 2 shall be replaced with "Queen's Way Service Road"


Proposed parking restrictions in Witts Hill

Proposed parking restrictions in Andromeda Road


