

# THE CITY OF SOUTHAMPTON (VARIOUS ROADS)

## (MOVEMENT RESTRICTIONS)(AMENDMENT NO 8)

### **TRAFFIC REGULATION ORDER 2013**

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2), and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended ("the Act") and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

#### 1 Citation and Commencement

This Order shall come into operation on 14<sup>th</sup> March 2013 and may be cited as the City of Southampton (Various Roads) (Movement Restrictions) (Amendment No 8) Traffic Regulation Order 2013.

#### 2 Interpretation

- (a) In this Order, "Principal Order" means The City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
- (b) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (c) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

# 3 Prohibition of Motor Vehicles in a Pedestrian Precinct

The following shall be added as a new paragraph to Article 10 to the Principal Order:

(o) save as provided in paragraphs (a), (d), (m) and (u) of Article 14, no person shall cause or permit any vehicle to enter or proceed in any length of road specified in Schedule 26A.

4 Article 14(u) shall be deleted and replaced by the following:

Nothing in Articles 6(j), 6(k) and 10(o) shall apply to any vehicle displaying a valid permit issued and used in accordance with the provisions of Article 15.

# 5 Article 15(a) shall be deleted and replaced by the following:

## Permits for Access to Pedestrian Zones

- (a) Any person who requires vehicular access to the lengths of road described in Schedules 5, 6 or 26A for any of the following purposes:-
  - (i) delivering or collecting goods or merchandise at 99 Above Bar Street;

- (ii) enabling a disabled person to board or alight from the vehicle at a specific property which that person regularly visits; or
- (iii) gaining access to the car park at One Guildhall Square
- (iv) in connection with any event as authorised by the Council


may apply to the Council for a permit to do so. Any such application shall be made on the form issued by and obtainable from the Council for that purpose and shall include the particulars and information required by such form to be supplied.

6 The contents of the Schedule to this Order shall be deleted from Schedule 26 and inserted as a new Schedule 26A to the Principal Order.
