

THE CITY OF SOUTHAMPTON COXFORD ROAD (MOVEMENT & WAITING) TRAFFIC REGULATION ORDER 2013

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (4), 4(2), 32(1), and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. CITATION

This Order shall come into operation on 25th March 2013 and may be cited as The City of Southampton Coxford Road (Movement & Waiting) Traffic Regulation Order 2013.

2. INTERPRETATION

- *i)* In this Order "Principal Order 1" means the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
- *ii)* In this Order "Principal Order 2" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
- *iii)* Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- *iv)* Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.
- v) The following definition shall be inserted into Article 2 of Principle Order 1.

"Horse-drawn vehicle" means a horse, pony or donkey, ridden or accompanied, drawing a wheeled conveyance (e.g. carriage).

3. PROHIBITION OF MOTOR VEHICLES AND HORSE-DRAWN VEHICLES

i) A new paragraph (n) shall be inserted into Article 10 of Principal Order 1.

Save as provided in paragraphs (a), (d), (h) and (p) of Article 14, no person shall cause or permit any motor vehicle or horse-drawn vehicle to enter or proceed in any length of road specified in Schedule 49.

ii) The paragraph reference "10(n)" shall be inserted into paragraphs (a), (d), (h) and (p) of Article 14.


4. WAITING RESTRICTIONS

- *i*) The contents of Schedule 1 shall be inserted as a new Schedule 49 in Principal Order 1.
- *ii)* The contents of Schedule 2 shall be inserted into Schedule 2.01 of Principal Order 2.

Coxford Road (unmade)	From the end of Coxford Road (made) outside 495 Coxford Road northwards to the Southampton city boundary	

Schedule 2: No Waiting at Any Time

Road	Side	Description
Coxford Road	Northern end (of made road)	For its entire length
Coxford Road	East	From the northern end of Coxford Road (made southwards for 10m
Coxford Road	West	From the northern end of Coxford Road (made southwards for 5m
