



**THE CITY OF SOUTHAMPTON
(SUBURBAN OFF-STREET PARKING PLACES)
(AMENDMENT NO 1) TRAFFIC REGULATION ORDER 2013**

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 32, 33 and 35(1) and (3) of the Road Traffic Regulation Act, 1984, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1 CITATION AND COMMENCEMENT

This Order shall come into operation on 6th September 2013 and may be cited as the City of Southampton (Suburban Off-Street Parking Places) Amendment 1 Order 2013.

2 INTERPRETATION

- (i) In this Order the "Principal Order 1" shall mean the City of Southampton (Suburban Off-Street Parking Places) Order 2011, as amended.
- (ii) In this Order "Principal Order 2" shall mean the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
- (iii) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

3 PARKING PLACES

The contents of Schedule 1 shall be deleted from Schedule 9.17 of Principle Order 1.

4 WAITING RESTRICTIONS

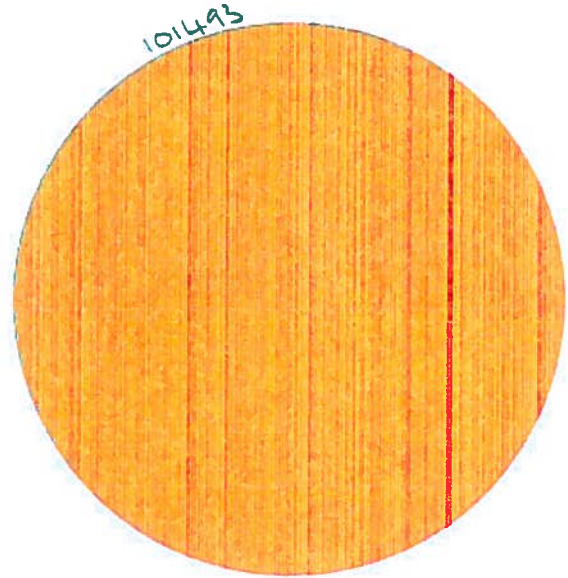
- (i) The contents of Schedule 2 shall be deleted from Schedule 2.01 of Principle Order 2.
- (ii) The contents of Schedule 3 shall be added to Schedule 2.01 of Principle Order 2.
- (iii) The contents of Schedule 4 shall be deleted from Schedule 2.03 of Principle Order 2.

Schedule 1: Parking Places for All Vehicles except Buses and Lorries, 2 Hour Limit, 8am-6pm, Monday to Saturday (No Return on Same Day)

Weston Lane Car Park: the land situated to the south of Weston Lane, opposite to Barnfield Road and bounded on the south-west by the footpath that leads from Kingsclere Avenue to Weston Lane.

Schedule 2: No Waiting at Any Time (Deletion)

Road	Side	Description
Kingsclere Close	Both	From the north-west kerb-line of Kingsclere Avenue north-westwards for 10m.
Kingsclere Avenue	North-west	From the south-western kerb-line of Wallace Road southwards to the north-eastern kerb-line of Kingsclere Close.
Kingsclere Avenue	North-west	From the south-western kerb-line of Kingsclere Close south-westwards for 30m.

Schedule 3: No Waiting at Any Time

Road	Side	Description
Kingsclere Avenue	North-west	From the south-western kerb-line of Wallace Road southwards for 71m.

Schedule 4: No Waiting 8am-6pm, Monday to Saturday

Road	Side	Description
Kingsclere Close	Both	From a point 10m north-west of the north-western kerb-line of Kingsclere Avenue north-westwards for 30m.
