



**THE CITY OF SOUTHAMPTON
(VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING)
(AMENDMENT NO. 22) TRAFFIC REGULATION ORDER 2013**

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 32(1), and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. CITATION

This Order shall come into operation on 4th November 2013 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment No. 22) Traffic Regulation Order 2013.

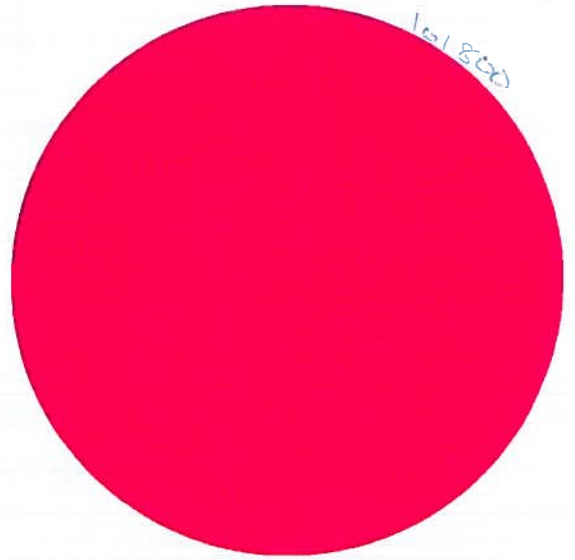
2. INTERPRETATION

- i)* In this Order "Principal Order" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011 as amended.
- ii)* Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- iii)* Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

3. WAITING RESTRICTIONS

- i)* The following shall be added as a new paragraph (h) to Article 10A:
"(h) between the hours of 7.30am and 6pm on any day other than a Saturday or a Sunday on the roads specified in Schedule 4.18".
- ii)* The contents of Schedule 1 shall be inserted into Schedule 2.03 to the Principal Order.
- iii)* The contents of Schedule 2 shall be inserted as a new Schedule 4.18 to the Principal Order.
- iv)* The contents of Schedule 3 shall be deleted from Schedule 2.03 to the Principal Order.

Road	Side	Description
Ashley Crescent (spine)	Outer side of crescent	From a point 10 metres south of its western junction with Portsmouth Road to its junction with Ashley Crescent (spur)
Ashley Crescent (spine)	Inner side of crescent	From a point 10 metres south of the easternmost junction with Portsmouth Road southwards westwards and northwards to a point 70 metres south of its westernmost junction with Portsmouth Road
Ashley Crescent (spur)	North	for its entire length

Schedule 2: No Stopping on zig-zag entrance markings 7.30am - 6pm Monday to Friday where marked in the following road

Schedule 3: No Waiting Mon - Sat 8am - 6pm - delete

Road	Side	Description
Ashley Crescent	North	From a point 10m south of the its eastern junction with Portsmouth Road southwards, westwards and northwards to a point 10m south of its western junction with Portsmouth Road
