

THE CITY OF SOUTHAMPTON (HOLYROOD ESTATE RESIDENTS' PARKING SCHEME) (AMENDMENT 1) TRAFFIC REGULATION ORDER 2013

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1 (1), 2 (1) to (3), 4 (1) and (2), 32 (1), 33, 35(1) and (3) and 45 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1 CITATION

This Order shall come into operation on 14 October 2013 and may be cited as The City of Southampton (Holyrood Estate Residents' Parking Scheme) (Amendment 1) Traffic Regulation Order 2013.

2 INTERPRETATION

- *i*) In this Order "Principal Order" means The City of Southampton (Holyrood Estate Residents' Parking Scheme) Traffic Regulation Order 2013.
- *ii)* Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- *iii)* Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

3 PAYMENT OF PENALTY CHARGE

The contents of Article 18 shall be deleted and replaced by the following:

- *i)* The owner of a vehicle in respect of which the penalty charge has been incurred shall pay the penalty charge to the Council EITHER by cheque or postal order which shall be delivered or sent by post so as to reach the Financial Services Division of the Council within 28 days of the issue of the penalty charge OR in cash in person at the said Division not later than as aforesaid OR by credit card or debit card.
- *ii)* If the penalty charge is paid before the end of the period of 14 days beginning with the date of the Notice, the amount of the penalty charge will be reduced by the specified proportion.
- *iii)* If the owner fails to pay the penalty charge by the end of the 28 day period, a Notice to Owner may be served; and if the charge is then not paid within a further 28 days it may be increased by 50%.


4 WAITING RESTRICTIONS

SCHEDULE 9.20: Holyrood Estate Residents' Parking Scheme ZONE 22 DELETION

Car Park H: Land bounded on the north by Eldon House, on the west by a point 27m east of the eastern kerb-line of Orchard Lane, on the east by a point 67m east of the eastern kerb-line of Orchard Lane and on the south by King Street.

Car Park J: Land bounded on the north by King Street, on the west by a point 58m east of the eastern kerb-line of Orchard Lane and on the west by a point 63m east of the eastern kerb-line of Orchard Lane.

Car Park N: Land bounded on the south by Marsh House, to the north by All Saints House and to the west by Orchard House.

Car Park P: from a point 50m south of the southern kerb-line of Lime Street southwards for 14m, bounded on the east by Orchard Lane.

Car Park S: Land bounded on the north by Challis Street, on the east by Threefield Lane, on the west by a point 71m east of the eastern kerb-line of King Street.

SCHEDULE 9.20: Holyrood Estate Residents' Parking Scheme ZONE 22 ADDITION

Car Park H: Land bounded on the north by Eldon House, on the west by a point 23m east of the eastern kerb-line of Orchard Lane, on the west by a point 45m east of the eastern kerb-line of Orchard Lane and on the south by King Street.

Car Park J: Land bounded on the north by King Street, on the west by a point 51m east of the eastern kerb-line of Orchard Lane and on the east by a point 73m east of the eastern kerb-line of Orchard Lane.

Car Park N: Land bounded on the south by Marsh House, to the north by All Saints House and to the west by Orchard Lane.

Car Park P: from a point 50m south of the southern kerb-line of Lime Street southwards for 14m, bounded on the east by King Street.

Car Park S: Land bounded on the north by Challis Court, on the east by Threefield Lane, on the west by a point 71m east of the eastern kerb-line of King Street.
