

# THE CITY OF SOUTHAMPTON (OFF-STREET PARKING PLACES) (AMENDMENT NO 6) TRAFFIC REGULATION ORDER 2013

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 32, 33 and 35(1) and (3) of the Road Traffic Regulation Act, 1984, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

#### 1 CITATION

This Order shall come into operation on 05 January 2014 and may be cited as The City of Southampton (Off-Street Parking Places) (Amendment No 6) Traffic Regulation Order 2013.

#### 2 INTERPRETATION

- (a) In this Order, "the Principal Order" shall mean the City of Southampton (Off-Street Parking Places) Traffic Regulation Order 2009, as amended.
- (b) Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.

#### 3 CHANGES TO INTERPRETATION

- (a) In Article 2(A) of the Principal Order the following expressions and meanings shall be removed in their entirety:
  - (i) "Day Time Season Ticket"
  - (ii) "Named Days"
- (b) In Article 2(A) of the Principal Order the following expressions and meanings shall be replaced as follows;
  - (i) "Charging Days" means those days other than Christmas Day and Easter Sunday which are specified in Schedules 9.01 to 9.13 for each parking place respectively.
  - (ii) "Daytime Charging Hours" means the period between 12 noon and 18.00 hours, on those charging days which are Sundays, Bank or Public Holidays, and the period between 08.00 hours and 18.00 hours on all other charging days, except:
    - (a) in Mayflower Park car park, where it means the period from sunrise to sunset on all charging day.
    - (b) in West Park Road car park, where it means the period between 08.00 hours and 22.00 hours on all charging days.

- (iii) "Parking Place" means an area of land specified by name in Schedules 9.01 to 9.13 and provided by the Council pursuant to Section 32(1) of the Act for the purpose of vehicle parking and not closed (in part or in whole) by a Notice erected thereon by authority of the Council.
- (iv) "Overnight Season Ticket" means a ticket purchased from the Council, subject to conditions of use, valid for the period specified on the ticket for use during overnight charging hours in parking places specified in Schedule 9.00C.
- (c) In Article 2(A) of the Principal Order the following expressions and meanings shall be inserted:
  - (i) ""Decrementing Card" means a pre-payment card for use in Eastgate MSCP, Grosvenor Square MSCP and Bedford Place MSCP with a 20% discount on charges and for use in Marlands MSCP without a 20% discount on charges."
  - (ii) ""MSCP" means multi-storey car park."
  - (iii) ""Evening Parking Pass" means a pass, subject to conditions of use, that may be issued at the discretion of the Council to registered charities or voluntary organisations, allowing the user to park in parking places specified in Schedule 9.00C without charge during any Overnight Charging Period, or to other organisations, at a reduced pre-paid charge, as specified in Article 24D."
  - (iv) ""Pay & Display" means parking that requires the driver to park the vehicle and then purchase and display a ticket, as described in Article 18 (ii), for the intended period stay."
  - (v) ""Pay on Foot" means parking that requires the driver to obtain a ticket at the entry barrier and pay for the period of stay at the Pay Station, as described in Article 20, before exiting."
  - (vi) ""Resident's Season Ticket" means a ticket, as specified in Article 24B, issued by the Council, subject to conditions of use, valid for the period specified on the ticket for use during all charging periods in the parking place or places specified on in Schedule 9.00C."
  - (vii) ""Season Ticket" means a ticket, as specified in Article 24 paragraphs (i), (ii), (iii), (viii), (ix), (x), (xi), (xii), (xiii) and (xiv), issued by the Council, subject to conditions of use, valid for the period specified on the ticket for use during all charging periods in the parking places specified in Schedule 9.00C."

#### 4 USE OF PARKING PLACES

The contents of paragraph (i) of Article 4 of the Principal Order shall be replaced with the following contents:

- "(i) Each parking place in Schedules 9.01 to 9.13 may be used for the parking of all vehicles except:
  - (a) vehicles exceeding 3.5 tonnes gross vehicle weight and vehicles adapted to carry more than 8 passengers exclusive of the driver except as provided under paragraph (e) below;
  - (b) vehicles drawing trailers in Grosvenor Square, Eastgate Street, Marlands, Salisbury Street and West Park Road multi-storey car parks;
  - (c) vehicles, any part of which exceeds 2.05 metres in height in Grosvenor Square, Eastgate Street, Marlands, Salisbury Street multi-storey car parks or 1.88 metres in height in West Park Road car park; and

- (d) vehicles of any description in Bargate Street car park, unless they are parked for the purpose of using the Shopmobility Scheme and display in a prominent position, so that it is facing forwards and can be entirely and easily seen from in front of the vehicle, a valid permit in writing issued by the operators of the Shopmobility Scheme, authorising the vehicle to be parked and clearly indicating the period of validity of the permit.
- (e) in the designated bus parking place in Mayflower car park, which may be only be used by buses and then for a maximum period of stay of 10 hours, within the same day, without charge."

#### 5 POSITION OF VEHICLES

The contents of Article 5 of the Principal Order will be replaced with the following:

- "(i) Motor cycles and pedal cycles permitted in the parking places shown in Schedules 9.01 to 9.13 and specified in Article 4, shall be positioned in bays marked "motor cycles" on the parking place, except in certain car parks which require a special manner of parking, as specified in Schedules 9.01 to 9.13.
- (ii) All other vehicles permitted to wait in the parking places, as shown Schedules 9.01 to 9.13 and specified in Article 4, shall be positioned in any other bays marked on the parking place, except in certain car parks which require a special manner of parking, as specified in Schedules 9.01 to 9.13.
- (iii) Every vehicle left in a parking place shall stand wholly within the limits of a parking bay where these are marked on the parking place."

#### 6 MAXIMUM PERIOD OF WAITING

The contents of Article 10, of the Principal Order, shall be replaced with the following:

"The maximum periods of waiting in the parking places and limitations on returning to them shall apply as specified in Schedule 9.00A."

### 7 MOVEMENT OF VEHICLES IN A PARKING PLACE IN EMERGENCIES

The contents of paragraph (ii) of Article 12 of the Principal Order shall be replaced with the following:

"Where a vehicle is left in a parking place in a position other than that specified in Article 5 and Schedules 9.01 to 9.13, a Police Constable in uniform or any other person duly authorised by the Council may move the vehicle or cause it to be moved to a position which complies with that specified in Article 5 and Schedules 9.01 to 9.13."

#### 8 PAY AND DISPLAY PARKING TICKETS

(a) The contents of Article 17, of the Principal Order, shall be replaced with the following:

"The driver of a vehicle left in accordance with the provisions of this Order during any charging period(s) or part(s) thereof in any parking place shown in Schedules 9.01, 9.02, 9.05, 9.06, 9.07, 9.08, 9.09, 9.10, 9.12 and 9.13 shall purchase a valid parking ticket at the tariffs stated in Schedules 9.00A and 9.00B for the relevant charging periods for the length of stay, on the day of purchase and exhibit the parking ticket on the vehicle in accordance with the provisions of Article 18(ii), except where the vehicle is:

(i) A Car Club vehicle parked in a designated Car Club bay or

- (ii) A Bus parked in the designated bus parking place in Mayflower Park Car Park.
- b) The contents of Article 18 of the Principal Order, shall be replaced with the following:
  - "A parking ticket used in a parking place shown in Schedules 9.01, 9.02, 9.05, 9.06, 9.07, 9.08, 9.09, 9.10, 9.12 and 9.13 shall only be a valid parking ticket if:
  - (i) It has been purchased from a ticket machine situated in the parking place where the vehicle is left or in another parking place that has the same car park code;
  - (ii) it is displayed on the vehicle:
    - (a) in the case of a vehicle fitted with a transparent windscreen, by displaying the ticket behind the windscreen at the near side of the vehicle so that the front of the ticket is clearly and entirely visible from outside the vehicle; or
    - (b) in the case of a vehicle not fitted with a transparent windscreen, by displaying the ticket in a conspicuous position at the front or near side of the vehicle so that the front of the ticket is clearly and entirely visible from outside the vehicle; AND
  - (iii) it has been so purchased and displayed in accordance with the following provisions:-
    - (a) in the parking places specified in 9.01, 9.02, 9.05, 9.06, 9.07, 9.08, 9.09, 9.10, 9.12 and 9.13, one ticket per vehicle shall be valid either from the time of purchase or if purchased when parking charges are not applicable from the beginning of the next following daytime charging period to the expiry time specified on the ticket so however that no such ticket shall be valid after the vehicle has exceeded within any daytime charging period the maximum period of waiting (if any) specified in Article 10;
    - (b) in the parking place specified in Schedule 9.06, one ticket per vehicle shall be valid at any time on the day of purchase for the period of 2 hours commencing either at the time and date specified on that ticket or, if purchased outside daytime charging hours, at the commencement of the next following period of daytime charging hours

#### 9 PAY ON FOOT PARKING

(a) The contents of paragraph (ii) of Article 20 of the Principal Order shall be replaced with the following:

"Subject to the provisions of paragraph (iv) below, the parking tariffs shown in Schedule 9.00A shall apply in respect of each daytime charging period or part thereof during which a vehicle is left in any of the parking places specified in Schedules 9.03 and 9.04."

(b) The contents of paragraph (iv) of Article 20 of the Principal Order shall be replaced with the following:

"Notwithstanding the provisions of paragraphs (ii) and (iii) above, if a vehicle enters any of the parking places specified in Schedules 9.03 and 9.04 during any daytime charging period and remains there until part of the immediately following overnight charging period has elapsed, the payment for stay will be calculated by the addition of the day time and overnight parking charges."

(c) The contents of paragraph (v) of Article 20 of the Principal Order shall be replaced with the following:

"In the event that the driver of a vehicle is unable to produce a ticket through loss or any other cause whatsoever he may obtain a validated ticket by making a payment at a pay station as follows:-

- (a) at the full daily rate specified in Schedule 9.00A for each daytime charging period or part thereof during which the vehicle has been left in the parking place and
- (b) at a rate of £3.00 for each overnight charging period or part thereof during which the vehicle has been left in the parking place."

#### 10 PEDAL CYCLES AND MOTOR CYCLES

The contents of Article 21 of the Principal Order shall be replaced with the following:

"The driver of a motor cycle or a pedal cycle which is left in accordance with the provisions of this Order in a parking place in the position specified for such vehicles as specified in Article 5 and Schedules 9.01 to 9.10, 9.12 and 9.13, shall be exempt from purchasing a parking ticket."

### 11 DISABLED PERSONS' AND ESSENTIAL VISITORS' VEHICLES

The contents of Article 22 of the Principal Order shall be replaced with the following:

- "(i) The driver of a vehicle left in accordance with the provisions of this Order in a parking place, shown in Schedules 9.01, 9.02, 9.05, 9.06, 9.07, 9.08, 9.09, 9.10, 9.12 and 9.13 shall be exempt from purchasing a parking ticket if the vehicle is:
  - (a) a vehicle which displays a Disabled Person's Badge in the manner prescribed by Regulation 12 of the Disabled Person's (Badges for Motor Vehicles) (England) Regulations 2000; OR
  - (b) a vehicle which displays a valid Essential Visitors' Parking Permit issued and used in accordance with the provisions of the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012.
- (ii) The restrictions imposed by Article 10 of this Order shall not apply to vehicles displaying a Disabled Person's Badge as described in paragraph (i)(a) of this Article."

#### 12 ABSENCE OF TICKET MACHINE

The contents of Article 23 of the Principal Order shall be replaced with the following:

"If at the time when a vehicle is left in a parking place shown in Schedules 9.01, 9.02, 9.05, 9.06, 9.07, 9.08, 9.09, 9.10, 9.12 and 9.13 there is no ticket machine at the parking place, or all the ticket machines at that parking place carry notices placed upon them by a person duly authorised by the Council indicating that they are out of order, the driver of that vehicle shall be exempt from purchasing a parking ticket."

#### 13 SEASON TICKETS AND BULK DISCOUNT AGREEMENTS

The contents of paragraph Article 24 will be replaced with the following:

"(i) A Season Ticket shall be available for the parking places specified in schedule 9.00C, subject to any limits on issue and at the discretion of the Council. The Season Ticket may be used for up to two nominated vehicles by the holder.

- providing that the vehicles comply with the requirements of Article 4 of this order and are not motorcycles.
- (ii) The driver of a vehicle left at any time in accordance with the provisions of this Order in a parking place as specified in paragraph (i) shall be exempt from purchasing a parking ticket if there is displayed in the manner prescribed for parking tickets in Article 18(ii) a valid Season Ticket purchased from the Council."
- (iii) The price of a Season Ticket shall be:

12 months: £1200.00 6 months: £600.00 3 months: £300.00

- (iv) An Overnight Season Ticket shall be available for the parking places specified in schedule 9.00C, subject to any limits on issue and at the discretion of the Council. The Overnight Season Ticket may be used for up to two nominated vehicles by the holder, providing that the vehicles comply with the requirements of Article 4 of this order and are not motorcycles.
- (v) The driver of a vehicle left during overnight charging hours in accordance with the provisions of this Order, in a parking place as specified in Schedule 9.00C of this order, shall be exempt from purchasing a parking ticket if there is displayed in the manner prescribed for parking tickets in Article 18(ii) a valid Overnight Season Ticket purchased from the Council.
- (vi) If a driver using a valid Overnight Season Ticket leaves a vehicle in any of the parking places specified in Schedule 9.03 and 9.04 of this order and does not remove that vehicle from the parking place until part of the next daytime charging period has elapsed, the driver will need to pay for the additional stay before exiting the car park. In the other car parks shown in Schedule 9.00C where Overnight Season Tickets are valid for use, vehicles may only stay over into the next day time charging period with the purchase of the appropriate Pay & Display ticket for the intended period of stay, prior to the commencement of that day time charging period.
- (vii) Subject to the provisions of paragraph (vi) above, the price of an Overnight Season Ticket shall be £150 for 12 months.
- (viii) If a Season Ticket or Overnight Season Ticket is lost or destroyed, the permit holder may apply to the Council for the issue of a duplicate ticket and the Council, upon being satisfied as to such loss or destruction, shall issue a duplicate ticket so marked and upon such issue the first ticket shall become invalid.
- (ix) The charge for a duplicate Season Ticket or Overnight Season Ticket issued under the provisions of paragraph (viii) above shall be £13.00.
- (x) The Council may from time to time make bulk discount agreements in respect of periods exceeding 12 months for the sale of quantities of season tickets at a preferential rate taking into account criteria including, but not limited to, the following:-
  - (a) the number of tickets bought;
  - (b) the duration of the agreement; and
  - (c) the benefits to the Council and the city in terms of inward investment.
- (xi) Any season ticket purchased under a bulk discount agreement shall be valid between the hours of 8 a.m. and Midnight. on any day of the week except Saturdays, Sundays and bank and public holidays and shall have a period of validity of 12 months, or any other period which the Council shall from time to time determine.

(xii) The price of a season ticket purchased under a bulk discount agreement shall be based upon the price of a 12 month season ticket shown in paragraph (iv)(a) of this Article and the following discounts shall apply:-

- (xiii) Any season ticket purchased under a bulk discount agreement shall only be valid while that agreement continues in force and the ticket is being used in accordance with the terms thereof.
- (xiv) Any season ticket holder may surrender the ticket to the Council at any time and, upon the surrender of the ticket, the Council shall refund a due proportion of the price of the permit in respect of each complete unexpired calendar month for which the permit would have been valid.

#### 14 RESERVED PARKING BAYS

Article 24A of the Principle Order shall be replaced with the following:

- (i) The Council shall from time to time and at its entire discretion reserve up to 450 parking bays within Eastgate Street Multi-Storey Car Park for use by holders of season tickets issued under the terms of a bulk discount agreement.
- (ii) The parking bays referred to in paragraph (i) above shall be reserved from 08.00 hours to Midnight on any day other than a Saturday, Sunday or bank or public holiday but shall be available for use by the public in accordance with the provisions of this Order at all other times.
- (iii) No person other than a season ticket holder acting in accordance with the terms of a bulk discount agreement shall cause or permit any vehicle to enter or remain in a parking bay during any period when it is reserved.
- (iv) The Council shall from time to time place within Eastgate Street Multi-Storey Car Park such signs, markings or barriers as it shall consider appropriate to indicate reserved parking bays or to restrict vehicular access to them and any vehicle left within a reserved parking bay shall display in the manner prescribed by Article 18 (ii) such form of identification as the Council shall from time to time require.
- (v) No season ticket which is valid in respect of reserved parking bays shall be valid in respect of any other parking bays.

#### 15 RESIDENTS SEASON TICKETS

A new Article 24B shall be inserted in to the Principal Order with the following content:

#### "RESIDENT'S SEASON TICKETS

(i) Any resident whose postal address is within the boundary of the city centre Pay & Display Zone, as signed, may apply to the Council for a Resident's Season

Ticket for a specified motor vehicle for the leaving of that vehicle, without charge in the parking place(s) specified in Schedule 9.00C and any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied.

- (ii) The Council may at any time require an applicant for a Resident's Season Ticket or a holder of such a ticket to produce to an officer of the Council such evidence in respect of an application for a ticket made to them as they may reasonably require to verify any particulars or information given to them or in respect of any ticket issued by them as they may reasonably require to verify that the ticket is valid.
- (iii) Without prejudice to the rights contained in paragraph (ii) of this Article to request information and evidence, the Council shall either:
  - (a) subject to the payment of the stipulated charge, issue to the applicant; a Resident's Season Ticket for the leaving in accordance with the provisions of this article or
  - (b) notify the applicant in writing of their refusal to issue a Resident Season Ticket:

PROVIDED THAT the Council shall have discretion to issue or refuse a Resident's Season Ticket

(iv) The price of a Resident's Season Ticket shall be:

12 months: £750.00 6 months: £375.00

- (v) A Resident's Season Ticket holder, for a Pay on Foot MSCP as specified in Schedule 9.00C of this order, leaving a vehicle during charging hours in accordance with the provisions of this Order shall be exempt from making a payment at a pay station for any charging period in respect of which a valid Resident Season Ticket for that car park has been used to gain access through the entry and exit barriers.
- (vi) A Resident's Season Ticket holder for any Pay and Display car park specified in Schedule 9.00C of this order, leaving a vehicle during charging hours in accordance with the provisions of this Order in a parking place as specified Schedule 9.00C shall be exempt from purchasing a parking ticket if there is displayed in the manner prescribed for parking tickets in Article 18(ii) a valid Resident's Season Ticket purchased from the Council.
- (vii) If a Resident Season Ticket is lost or destroyed, the permit holder may apply to the Council for the issue of a duplicate ticket and the Council, upon being satisfied as to such loss or destruction, shall issue a duplicate ticket so marked and upon such issue the first ticket shall become invalid.
- (viii) The charge for a duplicate Resident Season Ticket issued under the provisions of paragraph (viii) above shall be £13.00.
- (ix) The issue of Resident's Season Tickets may be limited at the discretion of the Council."

#### 15 SURRENDER AND VALIDITY OF SEASON TICKETS

A new Article 24C shall be inserted in to the Principal Order with the following content:

#### "SURRENDER AND VALIDITY OF SEASON TICKETS

- (i) Any Season Ticket, Overnight Season Ticket or Resident's Season Ticket holder may surrender the ticket to the Council at any time and, upon the surrender of the ticket, the Council shall refund a due proportion of the price of the ticket in respect of each complete unexpired calendar month for which the ticket would have been valid.
- (ii) The Council may, by notice in writing, withdraw a Season Ticket, Overnight Season Ticket or Resident's Season Ticket if it appears to the Council that any one of the events set out in paragraphs (iii) (a), (b), (c), (d), (e) or (f) of this Article has occurred and the Season Ticket, Overnight Season Ticket or Resident's Season Ticket holder shall surrender the permit to the Council within 48 hours of the receipt of the aforementioned Notice.
- (iii) The events referred to in the foregoing provisions of this Article are:
  - (a) the holder of a Resident's Season ticket ceasing to live at a postal address within the Pay & Display Zone, as signed.
  - (b) the Resident's Season ticket holder ceasing to be the owner of the vehicle in respect of which the permit was issued;
  - (c) the vehicle in respect of which a Season Ticket, Overnight Season Ticket or Resident's Season Ticket was issued being adapted or used in such a manner that it would be excluded from car parks as specified in Article 4 of this Order;
  - (d) the issue of a duplicate permit by the Council under the provisions of this Order; and
  - (e) the Season Ticket, Overnight Season Ticket or Resident's Season Ticket t ceasing to be valid pursuant to the provisions of paragraph (iv) of this Article.
  - (f) in the view of the Council the Season Ticket, Overnight Season Ticket or Resident's Season Ticket has been used in contravention of the instructions and conditions of use, or payment for the Season Ticket, Overnight Season Ticket or Resident's Season Ticket has not cleared.
- (iv) Without prejudice to the foregoing provisions of this Article a Season Ticket, Overnight Season Ticket or Resident's Season Ticket shall cease to be valid at the expiration of the period specified thereon or on the occurrence of anyone of the events set out in paragraphs (iii) (a), (b), (c), (d), (e) and (f) of this Article, whichever is the earlier."

#### 16 EVENING PARKING PASS

A new Article 24D will be inserted in to the Principal Order with the following content: "EVENING PARKING PASS

- (i) An Evening Parking Pass entitles the holder to park in those car parks specified in Schedule 9.00C, during the overnight charging period, under the provisions of this article. A pass user wishing to stay over to the next charging period will need to purchase a ticket after Midnight for any overstay into the next day time charging period.
- (ii) An Evening Parking Pass issued under the provisions of this Article shall only be valid so far as it is used in connection with the activities of the organisation to which the pass was issued and by an individual so authorised by that organisation to use the pass.

- (iii) Any charity (registered with the Charity Commission or any succeeding organisation fulfilling the same role), voluntary organisation (registered with the National Council for Voluntary Organisations or any succeeding organisation fulfilling the same role) operating within the boundary of the city centre Pay & Display Zone (as signed), may, subject to a successful application, be issued with a number of Evening Parking Passes subject to a maximum limit on issue.
- (iv) Any society or organisation, which the Council believes makes a contribution to the community, may subject to a successful application, be issued with a number of Evening Parking Passes at a cost of £1 per pass.
- (v) The Council may at any time require an applicant for Evening Parking Pass(es) or a holder of such a pass to produce to an officer of the Council such evidence in respect of an application for a pass made to them as they may reasonably require to verify any particulars or information given to them or in respect of any pass issued by them as they may reasonably require to verify that the pass is valid.
- (vi) Without prejudice to the rights contained in paragraph (v) of this Article to request information and evidence, the Council shall either:
  - (a) subject to the payment of the stipulated charge (if required) issue to the applicant; a Evening Parking Pass(es) for the leaving in accordance with the provisions of this article or
  - (b) notify the applicant in writing of their refusal to issue a Overnight Parking Pass(es):

PROVIDED THAT the Council shall have discretion to issue or refuse an application for an Evening Parking Pass.

#### 17 CONTRAVENTIONS

The contents of Article 28 of the Principal Order shall be replaced with the following:

"If a vehicle is left in a parking place referred to in Schedules 9.01 to 9.13 without complying with the requirements of this Order, a contravention shall have occurred and a penalty charge shall be payable."

#### 18 SUMMARY OF SCHEDULES



For the Mayflower Park car park charges apply from half an hour before sunrise to half an hour after sunset on every day of the week, for each 2 hour stay, with the exception of the bus parking bay where buses may park without charge for a maximum stay of 10 hours in the same day. For West Park Road Car Park, the day time charging period ends at 10pm. The maximum stay period applies to the Day time charging period and will extend to the commencement of the next day time charging period and staying over into the Overnight charging period (except Mayflower Park) will be subject to discrete tariffs for both 2

periods. The Limitation on Ketum only applies during the Day Time charging period. For all Pay & Display Car Parks a ticket purchase may only apply to the Day Time and Overnight charging periods on the day of purchase. To stay over into the next day time charging 6

period, will require a further ticket purchase between Midnight and 8am.
