

# THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (MOVEMENT RESTRICTIONS) (AMENDMENT NO 6) ORDER 2014

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, and 4 of the Road Traffic Regulation Act, 1984, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

#### CITATION

This Order shall come into operation on 5<sup>th</sup> May 2014 and may be cited as The City of Southampton (Various Roads) (Movement Restrictions) (Amendment No 6) Order 2014.

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order" shall mean the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

## WITH-FLOW BUS LANES

3 The contents of Schedule 1 to this Order shall be deleted from Schedule 8 of the Principal Order.

#### **ONE-WAY STREETS**

- 4 The contents of Schedule 2 to this Order shall be deleted from Schedule 12 of the Principal Order.
- 5 The contents of Schedule 3 to this Order shall be added to Schedule 12 of the Principal Order.


### PROHIBITION OF MOTOR VEHICLES
