



**THE CITY OF SOUTHAMPTON  
(BASSETT, HIGHFIELD AND HAMPTON PARK)  
(RESIDENTS' PARKING SCHEME) (AMENDMENT NO 2) ORDER 2014**

Southampton City Council (hereinafter called "the Council") under Sections 1 (1), 2 (1) to (3), 4 (1) and (2), 32 (1), 35 (1) and 124 of the Road Traffic Regulation Act 1984 as amended ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

**1 CITATION**

This Order shall come into operation on 2<sup>nd</sup> June 2014 and may be cited as the City of Southampton (Bassett, Highfield and Hampton Park) (Residents' Parking Scheme) (Amendment No 2) Order 2014.

**2 INTERPRETATION**

- (i) In this Order the "Principal Order" shall mean the City of Southampton (Bassett, Highfield and Hampton Park) (Residents' Parking Scheme) Order 2012, as amended.
- (ii) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

**3 WAITING RESTRICTIONS**

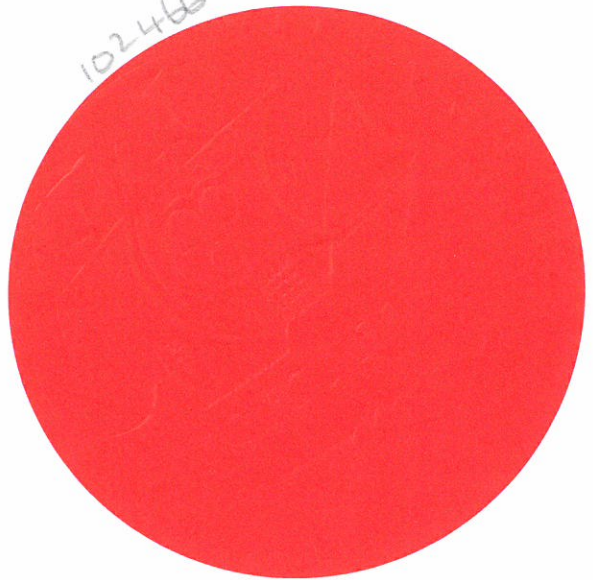
- (i) The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order.
- (ii) The contents of Schedule 2 shall be added to Schedule 2.01 to the Principal Order.
- (iii) The contents of Schedule 3 shall be deleted from Schedule 5.02 to the Principal Order.
- (iv) The contents of Schedule 4 shall be added to Schedule 5.02 of the Principal Order.

**Schedule 1: No Waiting at Any Time (deletion)**

Road	Side	Description
Burgess Road	North	From 4.5m west of the extended boundary of 321 / 323 Burgess Road eastwards to 2m east of the extended boundary of 329/331 Burgess Road (Zone 10).
Bassett Crescent East	Both	From the northern kerb-line of Burgess Road northwards for 15m.

**Schedule 2: No Waiting at Any Time (addition)**

Road	Side	Description
Burgess Road	North	From the extended boundary of 321 / 323 Burgess Road eastwards to 2m east of the extended boundary of 329/331 Burgess Road (Zone 10).
Entrance to Boldrewood site off Burgess Road	Both	From its junction with Burgess Road northwards to the highway boundary.
Bassett Crescent East	South-west	From the northern kerb-line of Burgess Road northwards for 15m.
Bassett Crescent East	North-east	From the northern kerb-line of Burgess Road northwards for 30m.

**Schedule 3: Parking Places with 1 Hour Limit, 8am-6pm, Monday to Friday, Except Permit Holders (No Return within Same Day to Same Street) (deletion)**

Road	Side	Description
Bassett Crescent East	North	From a point 15m north-west of the north-western kerb-line of Burgess Road to a point 60m north-west of the north-western kerb-line of Burgess Road (Zone 9).

**Schedule 4: Parking Places with 1 Hour Limit, 8am-6pm, Monday to Friday, Except Permit Holders (No Return within Same Day to Same Street) (addition)**

Road	Side	Description
Bassett Crescent East	North	From a point 30m north-west of the north-western kerb-line of Burgess Road to a point 60m north-west of the north-western kerb-line of Burgess Road (Zone 9).
