



THE CITY OF SOUTHAMPTON
(VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING)
(AMENDMENT NO. 16) TRAFFIC REGULATION ORDER 2013

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 32(1), 35(1) and (3), 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

1. CITATION

This Order shall come into operation on 2nd June 2014 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment No. 16) Traffic Regulation Order 2013.

2. INTERPRETATION

- i)* In this Order "Principal Order" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011 as amended.
- ii)* Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- iii)* Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

3. WAITING RESTRICTIONS

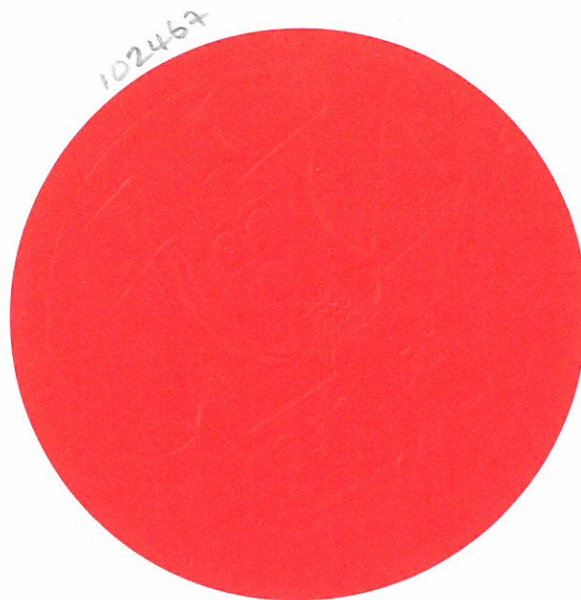
- i)* The contents of Schedule 1 shall be inserted into Schedule 2.01 to the Principal Order.
- ii)* The contents of Schedule 2 shall be deleted from Schedule 2.01 to the Principal Order.
- iii)* The contents of Schedule 3 shall be inserted into Schedule 6.02 to the Principal Order.

Schedule 1: No Waiting at Any Time

Road	Side	Description
Parkville Road	North-East	From the south-eastern kerb-line of the south-westbound carriageway of Stoneham Way south-eastwards to a point 59.5 metres north-west of the kerbline of its south-eastern closed end.
Parkville Road	North-east	From a point 25 metres north-west of the kerbline of its south-eastern closed end north-westwards for 25.5 metres.
Parkville Road	South-west	From the south-eastern kerb-line of the south-westbound carriageway of High Road south-eastwards to a point 59.5 metres north-west of the kerbline of its south-eastern closed end.
Parkville Road	South-west	From a point 21 metres north-west of the kerbline of its south-eastern closed end north-westwards for 10 metres.
Parkville Road	South-west	From a point 39 metres north-west of the kerbline of its south-eastern closed end north-westwards for 2.5 metres.
Parkville Road	South-eastern closed end	From a point 2 metres north-east of the south-western kerbline to a point 2 metres south-west of the north-eastern kerbline.

Schedule 2: No Waiting at Any Time (deletion)

Road	Side	Description
Parkville Road	North	From the south-eastern kerb-line of the south-westbound carriageway of Stoneham Way eastwards for 60 metres.
Parkville Road	South	From the southern kerb-line of the south-westbound carriageway of High Road eastwards for 35 metres.

Schedule 3: Parking Places with 1 Hour Limit, 8am-6pm, Monday to Saturday (No Return on Same Day)

Road	Side	Description
Parkville Road	North-east	From the kerbline of its south-eastern closed end north-westwards for 20 metres.
Parkville Road	North-east	From a point 45.5 metres north-west of the kerbline of its south-eastern closed end north-westwards for 14 metres.
Parkville Road	South-west	From a point 31 metres north-west of the kerbline of its south-eastern closed end north-westwards for 8 metres.
Parkville Road	South-west	From a point 41.5 metres north-west of the kerbline of its south-eastern closed end north-westwards for 18 metres.
