



**THE CITY OF SOUTHAMPTON (QUEENS PARK)  
ORDER (NO. 2) 2014**

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4, 32, 35, 45, 46, 49, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order:

**1 CITATION**

This Order shall come into operation on 9<sup>th</sup> June 2014, with the exception of Article 3 and schedule 9 which shall come into operation on 30<sup>th</sup> June 2014. This Order may be cited as the City of Southampton (Queens Park) Order (No. 2) 2014.

**2 INTERPRETATION**

- (i) In this Order the "Principal Order 1" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
- (ii) In this Order "Principal Order 2" shall mean the City of Southampton (Off-Street Parking Places) Traffic Regulation Order 2009, as amended.
- (iii) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (iv) Any reference in this Order to any enactment shall be construed as a reference to that enactment, as amended by any subsequent enactment.
- (v) The prohibitions, restrictions and requirements imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provisions of this Order is without prejudice to the provisions of any other enactment.

**3 CAR PARK**

All references to Queen's Terrace car park to be deleted from the Articles and Schedules of Principal Order 2.

**4 WAITING RESTRICTIONS**

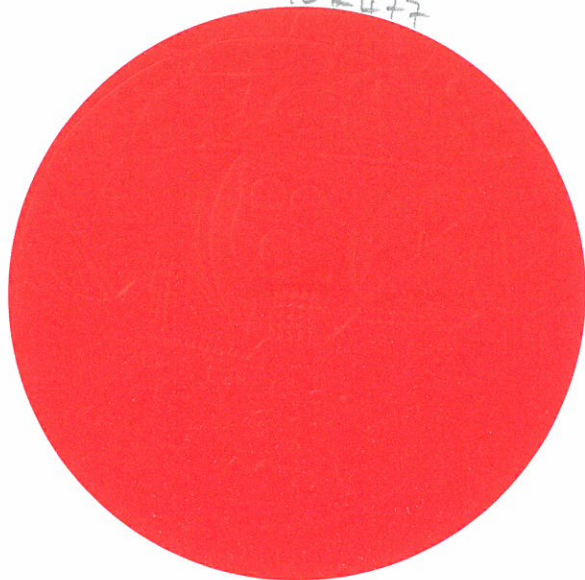
- i) The contents of Schedule 1 shall be deleted from Schedule 2.01 of Principal Order 1.

**Schedule 1: No Waiting at Any Time (Deletion)**

Road	Side	Description
Latimer Street	West	From the northern kerb-line of Platform Road northwards to 7m north of the northern kerb-line of Oxford Street.
Platform Road	South	From its junction with Canute Road westwards to 169m west of the western kerb line of Dock Gate 4.
Town Quay	North	From a point 95m east of the eastern kerblines of High Street eastwards to the western kerblines of Lower Canal Walk.

**Schedule 2: No Waiting at Any Time (Addition)**

Road	Side	Description
Latimer Street	West	From the northern kerb-line of Queen's Terrace northwards to 7m north of the northern kerb-line of Oxford Street.
Lower Canal Walk	East	From the northern kerb line of Town Quay northwards for 10m.
Platform Road	South	From its junction with Canute Road westwards to 30m west of the western kerb line of Dock Gate 4.
Platform Road	South	From 63m west of the western kerb line of Dock Gate 4 westwards to its junction with Town Quay.
Town Quay	North	From 95m east of the eastern kerblines of High Street eastwards to the western kerblines of Orchard Place.
Town Quay	South	From its junction with Platform westwards to its junction with west Quay Road.

**Schedule 3: No Waiting 8am to 8pm, Monday to Saturday and 1pm to 6pm Sunday (Deletions)**

Road	Side	Description
Latimer Street	East	From the northern kerb-line of Platform Road northwards to the southern kerb-line of Queens Terrace.
Lower Canal Walk	All	For their entire length.
Town Quay	North	From 27m east of the eastern kerb-line of Lower Canal Walk eastwards for 4m.
Town Quay	North	From the eastern kerb-line of Lower Canal Walk eastwards for 5m.

**Schedule 4: No Waiting 8am to 8pm, Monday to Saturday and 1pm to 6pm Sunday (Addition)**

Road	Side	Description
Lower Canal Walk	Closed end	For its entire length.
Lower Canal Walk	East	From 17.5m north of the northern kerb line of Town Quay northwards for 6m.
Lower Canal Walk	East	From 34.5m north of the northern kerb line of Town Quay northwards for 2.5m.
Lower Canal Walk	East	From 48m north of the northern kerb line of Town Quay northwards to its closed end.
Lower Canal Walk	West	For its entire length.

**Schedule 5: Motor Cycle Parking Places (Addition)**

Queen's Terrace	North	From 82m west of the western kerb line of the Latimer Street westwards for 5m.

**Schedule 6: Parking Places - Outer Area - Green Code Parking Places (Addition)**

Lower Canal Walk	East	From 10m north of the northern kerb line of Town Quay northwards for 7.5m (max. 3 bay, Angled).
Lower Canal Walk	East	From 23.5m north of the northern kerb line of Town Quay northwards for 11m (max. 2 bay, Parallel).
Lower Canal Walk	East	From 37m north of the northern kerb line of Town Quay northwards for 11m (max. 2 bay, Parallel).
Queen's Terrace	North	From 87m west of the western kerb line of the Latimer Street westwards for 27.5m (max. 5 bays, Parallel).
Queen's Terrace	South	From 28.5m west of the western kerb line of the Latimer Street westwards for 82.5m (max. 15 bays, Parallel).

Town Quay	North	From 5m east of the eastern kerb-line of Lower Canal Walk eastwards for 22m (max. 8 bays, Angled).
