



**THE CITY OF SOUTHAMPTON**  
**(VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING)**  
**(AMENDMENT NO. 26) TRAFFIC REGULATION ORDER 2014 Part A**

Southampton City Council ("the Council") in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 32(1), and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and Sections 63 and 64 of the Local Government (Miscellaneous Provisions) Act 1976 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

**1 CITATION**

This Order shall come into operation on 30<sup>th</sup> June 2014 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment No. 26) Traffic Regulation Order 2014 Part A.

**2 INTERPRETATION**

- (i) In this Order "Principal Order No 1" means The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011 as amended.
- (ii) In this Order "Principal Order No 2" means The City of Southampton (Bassett, Highfield and Hampton Park) (Residents' Parking Scheme) Order 2012 as amended.
- (iii) Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (iv) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

**3 WAITING RESTRICTIONS**

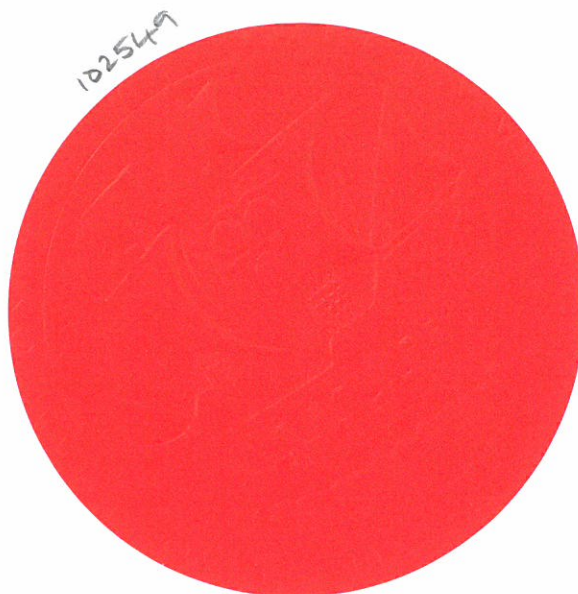
- (i) The following shall be added as a new Article 5(B)(xvii) to Principal Order No 1: "any vehicle to wait between the hours of 6.00am to 6.00pm, for a longer period than 3 hours, or for more than one period in the same street on the same day, in the parking places specified in Schedule 6.32".
- (ii) The road "Market Buildings" shall be inserted into Schedule 8.05 to Principal Order No 1.
- (iii) The contents of Schedule 1 shall be inserted into Schedule 2.01 to Principal Order No 1.
- (iv) The contents of Schedule 2 shall be inserted as a new Schedule 6.32 to Principal Order No 1.
- (v) The contents of Schedule 3 shall be deleted from Schedule 2.01 to Principal Order No 2.
- (vi) The contents of Schedule 4 shall be deleted from Schedule 5.03 to Principal Order No 2.
- (vii) The contents of Schedule 5 shall be added to Schedule 5.03 to Principal Order No 2.

Market Buildings	North	From a point 15.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 5 metres
Market Buildings	North	From a point 30 metres east of the eastern kerbline of Stoneham Lane eastwards for 1.5 metres
Market Buildings	North	From a point 34 metres east of the eastern kerbline of Stoneham Lane eastwards for 2.5 metres
Market Buildings	North	From a point 39 metres east of the eastern kerbline of Stoneham Lane eastwards for 3.5 metres
Market Buildings	North	From a point 49.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 6.5 metres
Market Buildings	North	From a point 67.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 1.5 metres
Market Buildings	North	From a point 78.5 metres east of the eastern kerbline of Stoneham Lane eastwards to the northern kerbline of Stoneham Way
Market Buildings	South	From the eastern kerbline of Stoneham Lane eastwards for 5 metres
Market Buildings	South	From a point 25 metres east the eastern kerbline of Stoneham Lane eastwards for 2 metres
Market Buildings	South	From a point 36 metres east the eastern kerbline of Stoneham Lane eastwards for 2 metres
Market Buildings	South	From a point 45.5 metres east the eastern kerbline of Stoneham Lane eastwards for 1.5 metres
Market Buildings	South	From a point 67 metres east of the eastern kerbline of Stoneham Lane eastwards to the northern kerbline of Stoneham Way

Market Buildings	North	From a point 20.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 9.5 metres (echelon parking)
Market Buildings	North	From a point 31.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 2.5 metres (echelon parking)
Market Buildings	North	From a point 36.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 2.5 metres (echelon parking)
Market Buildings	North	From a point 42.5 metres east of the eastern kerbline of Stoneham Lane eastwards for 7 metres (echelon parking)
Market Buildings	North	From a point 56 metres east of the eastern kerbline of Stoneham Lane eastwards for 11.5 metres (echelon parking)
Market Buildings	North	From a point 69 metres east of the eastern kerbline of Stoneham Lane eastwards for 9.5 metres (echelon parking)
