

#### THE CITY OF SOUTHAMPTON (CHURCH STREET) ORDER 2014

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act, 1984, ("the Act") and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

#### CITATION

1 This Order shall come into operation on 1<sup>st</sup> November 2014 and may be cited as The City of Southampton (Church Street) Order 2014.

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order 1" shall mean the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
  - (ii) "Principal Order 2" shall mean the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
  - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

#### MOVEMENT RESTRICTIONS

- 3 The contents of Article 6(g) of Principal Order 1 shall be deleted and replaced with the following:
  - "Save as provided in paragraphs (a), (d), (f), (g), (h), (k) and (s) of Article 14, no person shall cause or permit any vehicle to enter or proceed in any cycle lane specified in Schedules 10, 11 and 11a during the hours of operation."
- 4 The contents of Schedule 1 shall be deleted from Schedule 11 to Principal Order 1.
- 5 The contents of Schedule 2 shall be inserted into Schedule 12 to Principal Order 1.
- 6 The contents of Schedule 3 shall be inserted into Principal Order 1 as a new schedule 11a.


#### **WAITING RESTRICTIONS**

- 7 The contents of Schedule 4 shall be deleted from Schedule 2.01 to Principal Order 2.
- 8 The contents of Schedule 5 shall be inserted into Schedule 2.01 to Principal Order 2.
- 9 The contents of Schedule 6 shall be deleted from Schedule 2.03 to Principal Order 2.
- 10 The contents of Schedule 7 shall be inserted into Schedule 2.03 to Principal Order 2.

Church Street	South-east	From 46m south-west of its junction with Salem Street to 12m south-west of its junction with Vincent Rd
