



THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT NO 31) ORDER 2014

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act"), and all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on 15th December 2014 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 31) Order 2014.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
 - (ii) "Principal Order 2" shall mean The City of Southampton (Bevois Town) (Residents' Parking Scheme) Order 2009, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

NO STOPPING ON ZIG-ZAG ENTRANCE MARKINGS

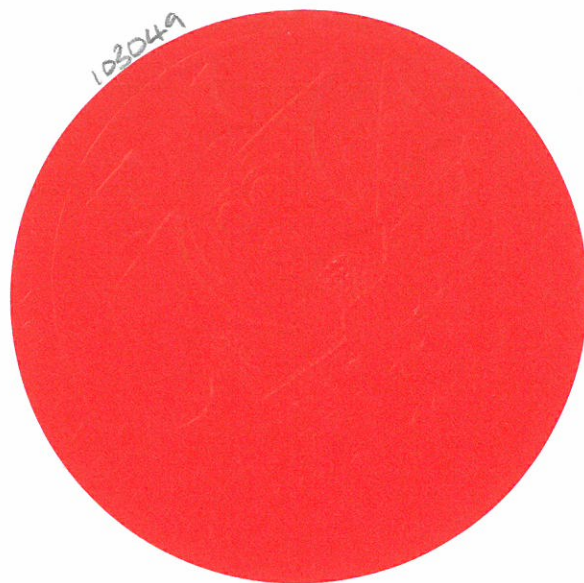
- 3 The following shall be inserted into Principal Order 1 as a new paragraph 10A(i)(h):

"between the hours of 8am and 9.30am and between the hours of 2.30pm and 5pm on any day other than a Saturday or a Sunday on the roads specified in Schedule 4.15 to this Order"
- 4 The contents of Schedule 1 shall be inserted into Principal Order 1 as a new Schedule 4.15
- 5 The contents of Schedule 2 shall be inserted into Schedule 4.09 to Principal Order 1.
- 6 The contents of Schedule 3 shall be deleted from Schedule 5.10 to Principal Order 2.
- 7 The contents of Schedule 4 shall be inserted into Schedule 5.10 to Principal Order 2.
- 8 The contents of Schedule 5 shall be deleted from Schedule 2.01 to Principal Order 2.
- 9 The contents of Schedule 6 shall be inserted into Schedule 2.01 to Principal Order 2.

Schedule 2 - No Stopping on zig-zag entrance markings 8am-6pm Monday to Friday where marked in the following roads (Addition):

Townhill Way

Victor Street

Schedule 3 - Parking Places with 2 Hour Limit (No Return within Same Day), 8am-6pm, Monday to Saturday and During Stadium Events, Except Permit Holders (Deletion)

Road	Side	Description
Earls Road	West	From a point 7m north of the extended northern kerb-line of Ancasta Road northwards to the northern boundary line of No.41 Forster Road

Schedule 4 - Parking Places with 2 Hour Limit (No Return within Same Day), 8am-6pm, Monday to Saturday and During Stadium Events, Except Permit Holders (Addition)

Road	Side	Description
Earls Road	West	From a point 7m north of the extended northern kerb-line of Ancasta Road northwards to 12m south of the northern boundary line of No.41 Forster Road

Schedule 5 – No Waiting at any Time (Deletion)

Road	Side	Description
Earls Road	West	From the northern boundary line of No.41 Forster Road northwards to a point 10m north of the northern kerb-line of Lodge Road

Schedule 6 – No Waiting at any Time (Addition)

Road	Side	Description
Earls Road	West	From 12m south the northern boundary line of No.41 Forster Road northwards to a point 10m north of the northern kerb-line of Lodge Road
