

THE CITY OF SOUTHAMPTON (FIRST CONTROLLED ZONE) (AMENDMENT 11) ORDER 2015

Southampton City Council (hereinafter called "the Council") in exercise of its powers under Sections 45, 46, and 49 of the Road Traffic Regulation Act, 1984, ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 8th March 2015 and may be cited as The City of Southampton (First Controlled Zone) (Amendment 11) Order 2015.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

ARTICLE AMENDMENTS

- 3 The expression "Daytime Charging Hours" and its meaning contained in Article 2A of the Principal Order shall be replaced with the following:
 - ""Daytime Charging Hours" means the period between 8.00am and 6.00pm on Monday to Saturday and between 1.00 pm and 6.00 pm on Sundays, Public and Bank Holidays (except Christmas Day and Easter Sunday when parking will be free)."
- The expression "Evening Charging Hours" and its meaning contained in Article 2A of the Principal Order shall be replaced with the following:
 - ""Evening Charging Hours" means the period between 6:00pm and 8:00pm on Monday to Saturday (excepting Christmas Day)."
- 5 The expression "Evening Parking Pass" and its meaning contained in Article 2A of the Principal Order shall be replaced with the following:
 - "Evening Parking Pass" is a pass that may be issued to registered charities or voluntary organisations or other organisations contributing to the community in accordance with the provisions of the City of Southampton (Off-Street Parking Places) Traffic Regulation Order 2009 (as amended). The Evening Parking Pass allows the user to park in parking places specified in Schedules 8.01, 8.02, 8.03 without charge or with a reduced prepaid charge during any Evening Charging Hours.
- The expression "Permitted Hours" and its meaning contained in Article 2A of the Principal Order shall be replaced with the following:
 - "Permitted Hours" means the period between 8:00am and 8:00pm Monday to Saturday and between 1.00pm and 6.00pm on Sundays, Public and Bank Holidays (excluding Christmas

Day and Easter Sunday) except with regards to the Parking Places in Rockstone Place where it means the period between 8:00am and 6:00pm Monday to Saturday and 1:00pm and 6:00pm Sundays, Public and Bank Holidays (excluding Christmas Day and Easter Sunday).

7 The expression "Restricted Hours" and its meaning contained in Article 2A of the Principal Order shall be replaced with the following:

""Restricted Hours" means:

- (i) in relation to any restriction specified in Schedules 2.02, 8.01, 8.02 and 8.03 means the period between 8:00am and 8:00pm Monday to Saturday and between 1.00pm and 6.00pm on Sundays, Public and Bank Holidays (excluding Christmas Day and Easter Sunday) except with regards to Parking Places in Rockstone Place where it means the period between 8:00am and 6:00pm Monday to Saturday and 1:00pm and 6:00pm Sundays, Public and Bank Holidays (excluding Christmas Day and Easter Sunday); and
- (ii) in relation to any restricted road specified in Schedules 2.01, 2.14, 7.01, 7.02, 7.04, 7.07 and 7.11 and 7.14, the whole twenty four hours of every day; and
- (iii) in relation to any restricted road specified in Schedule 2.18 from Midnight to 6am every day; and
- (iv) in relation to any restricted road specified in Schedule 2.19, the period between 10.00 am and 11.00 am on any day other than a Sunday
- (v) in relation to any restricted road specified in Schedule 2.23, the period between 8.00 am and 6.00 pm on Monday to Saturday and on Sundays, Public and Bank Holidays (excepting Christmas Day and Easter Sunday when parking will be allowed) between 1.00 pm and 6.00 pm."
- 8 The contents of Article 11 of the Principal Order shall be replaced with the following:
 - "Each area on the carriageway of a highway in the City of Southampton which is bounded on the side shown in column 2 of Schedules 8.01, 8.02 and 8.03 by so much of the edge of the carriageway as is shown in column 3 of those Schedules is hereby designated as a parking place for the purposes of this Order."
- 9 The contents of Article 12 of the Principal Order shall be replaced with the following:
 - "The number of parking bay(s) in each parking place shall not exceed the number specified in column 3 of Schedules 8.01, 8.02 and 8.03 in relation to that parking place. The layout (parallel, perpendicular, angled) of parking bay(s) relative to the edge of the carriageway shall also be specified in column 3 of Schedules 8.01, 8.02 and 8.03 together with any variation that may apply from the layout definition as detailed in Article 2A"
- The contents of Article 28(v) of the Principal Order shall be replaced with the following: "the vehicle is waiting in a parking place specified in column 4 of schedule 8.01, 8.02 or 8.03 as being part of a residents parking zone and is displaying in the relevant position a valid
- resident's permit for that zone."

 11 The contents of Article 28(vii) of the Principal Order shall be replaced with the following:
 - "the vehicle displays a valid evening Season Ticket in parking places described in schedules 8.01, 8.02 and 8.03 during the Evening Charging Hours, issued and used in accordance with the provisions of Article 28A"
- 12 The contents of Article 28A(iv) of the Principal Order shall be replaced with the following:
 - "An Evening and Weekend Season Ticket is a season ticket allowing the valid holder, issued under the provisions of this article, to park in parking places specified in Schedules 8.01,

8.02 and 8.03 without charge during any Evening Charging Hours and during the Daytime Charging hours on Saturday, Sunday and Bank/Public holidays, at a cost of £400 per year"

13 The contents of Article 38 of the Principal Order shall be replaced with the following:

"APPLICATION FOR ROCKSTONE PLACE RESIDENT'S PERMITS

Any person whose usual place of residence is at premises the postal address of which is in the opinion of the Council is entitled to Rockstone Place Resident's Permits and

- (i) is the owner of a vehicle of the following class, that is to say a passenger vehicle, a goods vehicle or a motorcycle, or
- (ii) with the permission of the owner uses a vehicle of the said class on a regular basis during the course of his employment,

provided that the maximum gross weight of the vehicle does not exceed 3.5 tonnes, is no more than 5 metres in length or is not constructed to carry more than 8 seated passengers, excluding the driver.

may apply to the Council for the issue of a residents' permit for the leaving of that vehicle in the parking places specified as Zone 18. Any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied.

Save as provided by this Order, there shall be no entitlement to visitors' permits, business permits or temporary business permits within Rockstone Place (Zone 18)."

14 The content of Article 39 of the Principal Order shall be replaced with the following:

"APPLICATION FOR CITY CENTRE RESIDENT'S PERMITS

Any person whose usual place of residence is at premises the postal address of which is in the opinion of the Council entitled to City Centre Residents Permits and

- (i) is the owner of a vehicle of the following class, that is to say a passenger vehicle, a goods vehicle or a motor cycle, not exceeding 5m in length, OR
- (ii) with the permission of the owner uses a vehicle of the said class, not exceeding 5m in length, on a regular basis during the course of his employment,

provided that the maximum gross weight of the vehicle does not exceed 3.5 tonnes, is no more than 5 metres in length or is not constructed to carry more than 8 seated passengers, excluding the driver.

may apply to the Council for the issue of a residents' permit for the leaving of that vehicle in the relevant parking places within Zone A. Any such application shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied.

In the case of sub-divided properties the allocation of permits is subject to any appropriate planning consent having been obtained for the subdivision of the property.

Save as provided by this Order, there shall be no entitlement to visitors' permits, business permits or temporary business permits within the City Centre Residents' Parking Scheme."


ADDITION/AMENDMENT OF SCHEDULES
