



THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 35) (PART 2) ORDER 2014

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 29th June 2015 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 35) (Part 2) Order 2014.

INTERPRETATION

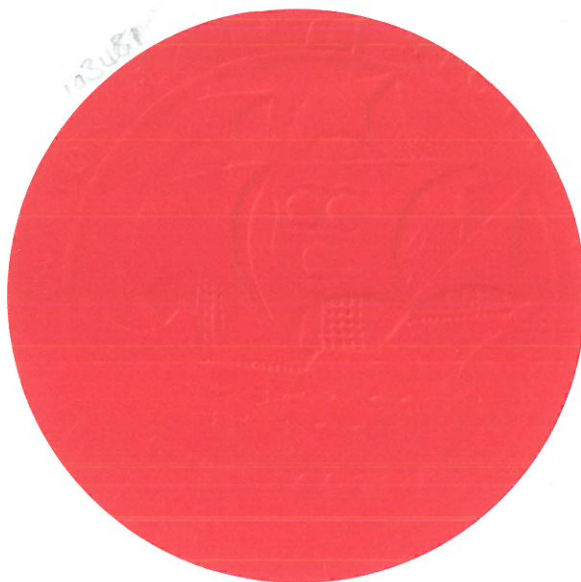
- 2** In this Order:
 - (i) "Principal Order" shall mean the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3** The contents of schedule 1 shall be deleted from schedule 2.01 of the Principal Order.
- 4** The contents of schedule 2 shall be inserted into schedule 2.01 of the Principal Order.
- 5** The contents of schedule 3 shall be deleted from schedule 6.05 of the Principal Order.

SCHEDULE 1 – No Waiting at Any Time (Deletion)

Road	Side	Description
Second Avenue	North-east	From the south-eastern kerb-line of First Avenue (north-western arm) south-eastwards for 125m
Second Avenue	North-east	From the south-eastern kerb-line of Allington Road south-eastwards for 22m
Second Avenue	North-east	From a point 102m south-east of the south-eastern kerb-line of Allington Road south-eastwards for 298m
Second Avenue	South-west	From the north-western kerb-line of First Avenue (south-eastern arm) westwards to the south-eastern kerb-line of First Avenue (north-western arm)
Second Avenue	South-west	From the north-western kerb-line of First Avenue (north-western arm) north-westwards to the south-eastern kerb-line of Allington Road

SCHEDULE 2 – No Waiting at Any Time (Addition)

Road	Side	Description
Second Avenue	Both	Link road between Redbridge Road and Second Avenue for its entire length
Second Avenue	North-east	From the eastern kerb line of Allington Road to 86m north-west of the north-western kerb line of the Second Avenue link road between Redbridge Road and Second Avenue
Second Avenue	North-east	From 32m north-west of the north-western kerb line of the Second Avenue Spur Road between Redbridge Road and Second Avenue to 20m south-east of the south-eastern kerblines of Second Avenue Spur Road between Redbridge Road and Second Avenue
Second Avenue	North-east	From its closed end north-west for 38m
Second Avenue	South-west	For its entire length
Second Avenue	Closed End	For its entire length

SCHEDULE 3 – Parking Places with 2 hour limit Monday - Saturday 8am – 6pm no return 2 hours (Deletion)

Road	Side	Description
Second Avenue	North east	From a point 22m south east of the south-eastern kerb-line of Allington Road south-eastwards for 80m
