



## **THE CITY OF SOUTHAMPTON (FIRST CONTROLLED ZONE) (AMENDMENT 14) ORDER 2015**

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

### **CITATION**

- 1** This Order shall come into operation on 24<sup>th</sup> August 2015 and may be cited as The City of Southampton (First Controlled Zone) (Amendment 14) Order 2015.

### **INTERPRETATION**

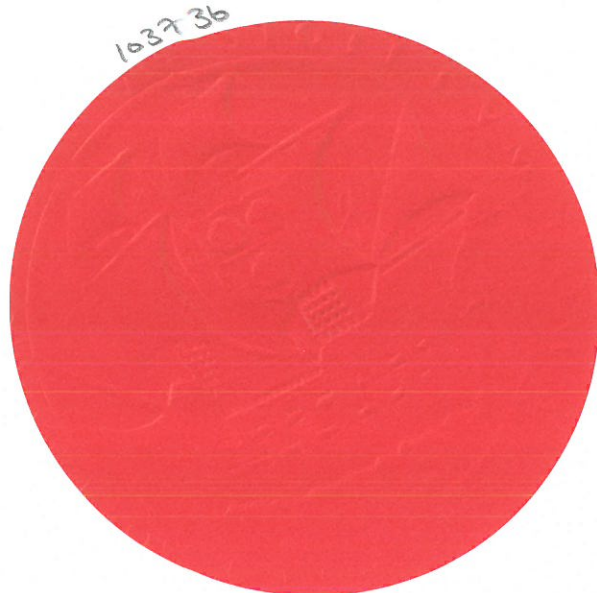
- 2** In this Order:
  - (i) "Principal Order" means the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3** The contents of schedule 1 shall be deleted from schedule 2.01 of the Principal Order.
- 4** The contents of schedule 2 shall be inserted into schedule 2.01 of the Principal Order.
- 5** The contents of schedule 3 shall be deleted from schedule 2.02 of the Principal Order.
- 6** The contents of schedule 4 shall be inserted into schedule 2.02 of the Principal Order.
- 7** The contents of schedule 5 shall be deleted from schedule 8.03 of the Principal Order.
- 8** The contents of schedule 6 shall be inserted into schedule 8.03 of the Principal Order.

**SCHEDULE 1 – No Waiting at Any Time (Deletion)**

Road	Side	Description
Western Esplanade	East	From 10m north of the northern flank wall of the Royal Standard Public House southwards to the north-eastern kerb-line of Western Esplanade
Western Esplanade	East	From 42m south of the closed section of Western Esplanade southwards to 20m north of the northern flank wall of the Royal Standard Public House

**SCHEDULE 2 – No Waiting at Any Time (Addition)**

Road	Side	Description
Western Esplanade (part stopped up)	East	From the north-eastern kerbline of West Quay Road northwards for 42m
Western Esplanade (part stopped up)	East	From 62m north of the north-eastern kerbline of West Quay Road northwards for 78m
Western Esplanade (part stopped up)	East	From 184m north of the north-eastern kerbline of West Quay Road northwards for 5m

**SCHEDULE 3 – No Waiting 8am - 8pm, Monday to Saturday and 1pm to 6pm, Sunday (Deletion)**

Road	Side	Description
Western Esplanade	East	From 10m north of the northern flank wall of the Royal Standard Public House northwards for 10m

**SCHEDULE 4 – No Waiting 8am - 8pm, Monday to Saturday and 1pm to 6pm, Sunday (Addition)**

Road	Side	Description
Western Esplanade (part stopped up)	East	From 42m north of the north-eastern kerbline of West Quay Road northwards for 20m

**SCHEDULE 5 – Parking Places – Outer Tariff (Grey) (Deletion)**

Road	Side	Description	Zone
Western Esplanade (southern section)	East	From 27m south of the closed section of Western Esplanade southwards for 15m (max. 3 bays, Parallel)	N/A
Western Esplanade (southern section)	East	From the closed section of Western Esplanade southwards for 27m (max. 9 bays, Angled)	N/A

**SCHEDULE 6 – Parking Places – Outer Tariff (Grey) (Addition)**

Road	Side	Description	Zone
Western Esplanade (part stopped up)	East	From 140m north of the north-eastern kerbline of West Quay Road northwards for 44m (angled bays)	N/A
Western Esplanade (part stopped up)	East	From 189m north of the north-eastern kerbline of West Quay Road northwards to its closed end (angled bays)	N/A
