

#### THE CITY OF SOUTHAMPTON (MOTORCYCLE AND BUS PARKING) ORDER 2015

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

#### CITATION

1 This Order shall come into operation on 19<sup>th</sup> October 2015 and may be cited as The City of Southampton (Motorcycle and Bus Parking) Order 2015.

#### INTERPRETATION


- 2 In this Order:
  - "Principal Order 1" shall mean the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
  - (ii) "Principal Order 2" shall mean the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
  - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3 The following shall be inserted into Principal Order 2 as a new 5(I):
  - "Save as provided in Article 7(i) and (iv), no person shall, except upon the direction or with the permission of a Police Constable in uniform, cause or permit:
  - (i) any vehicle other than a bus to wait in the parking places specified in Schedule 7.15
  - (ii) a bus to wait for a period of more than 15 minutes, or if a period of less than 30 minutes has elapsed since the termination of the last period of waiting of the vehicle (if any) in the parking places specified in Schedule 7.15
  - (iii) any vehicle other than a bus to wait in the parking places specified in Schedule 7.16 between 8am and 6pm Monday to Saturday
  - (iv) a bus to wait for a period of more than 4 hours, or for more than one period in the same street on the same day, in the parking places specified in Schedule 7.16
- 4 The contents of schedule 1 shall be deleted from schedule 2.01 of Principal Order 1.
- 5 The contents of schedule 2 shall be inserted into schedule 2.01 of Principal Order 1.
- 6 The contents of schedule 3 shall be deleted from schedule 7.01 of Principal Order 1.
- 7 The contents of schedule 4 shall be inserted into schedule 7.01 of Principal Order 1.
- 8 The contents of schedule 5 shall be deleted from schedule 8.01 of Principal Order 1.

- 9 The contents of schedule 6 shall be inserted into schedule 8.01 of Principal Order 1.
- 10 The contents of schedule 7 shall be deleted from schedule 2.01 of Principal Order 2.
- 11 The contents of schedule 8 shall be inserted into schedule 2.01 of Principal Order 2.
- 12 The contents of schedule 9 shall be deleted into schedule 2.03 of Principal Order 2.
- 13 The contents of schedule 10 shall be deleted from schedule 5.13 of Principal Order 2.
- 14 The contents of schedule 11 shall be inserted into schedule 5.13 of Principal Order 2.
- 15 The contents of schedule 12 shall be inserted into Principal Order 2 as a new schedule 7.15.
- 16 The contents of schedule 13 shall be inserted into Principal Order 2 as a new schedule 7.16.

Commercial Road	North	From its junction with Above Bar Street westwards to 3.5m west of the eastern kerb-line of West Marlands Road
Commercial Road	North	From a point 14.5m west of the eastern kerb-line of West Marlands Road westwards for 4m
Commercial Road	North	From 72m west of the eastern kerb-line of West Marlands Road westwards for 5m
Commercial Road	North	From 116m west of the eastern kerb-line of West Marlands Road westwards to 109m west of the western kerb-line of Cumberland Place

Commercial Road	North	From the western kerbline of Above Bar Street westwards for 37m
