



## **THE CITY OF SOUTHAMPTON (RESIDENTS PARKING) (ZONES 1–12 & 16) (AMENDMENT 5) ORDER 2015**

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

### **CITATION**

- 1** This Order shall come into operation on 25<sup>th</sup> April 2016 and may be cited as The City of Southampton (Residents Parking) (Zones 1–12 & 16) (Amendment 5) Order 2015.

### **INTERPRETATION**

- 2** In this Order:
  - (i) “Principal Order” shall mean The City of Southampton (Residents Parking) (Zones 1–12 & 16) Order 2014, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

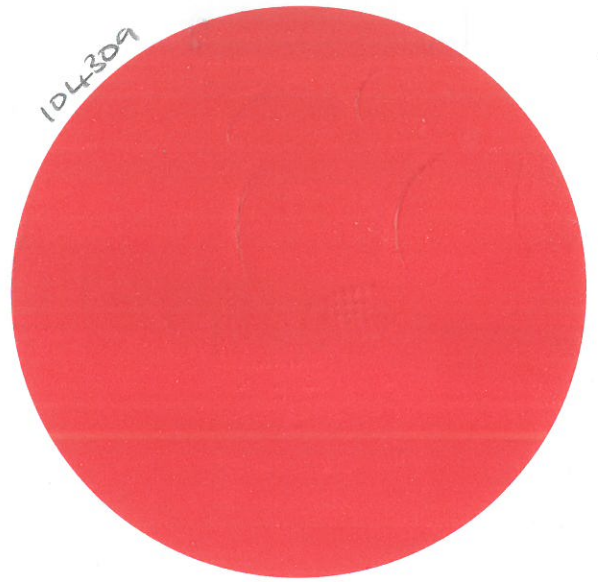
### **AMENDMENTS**

Johns Road	East	From the southern kerb-line of Portsmouth Road southwards for 10m	2
Johns Road	East	From a point 25m south of the southern kerb-line of Portsmouth Road southwards for 19m	2

**SCHEDULE 2 – No waiting at any time (Addition)**

Road	Side	Description	Zone
Johns Road	East	From the southern kerb-line of Portsmouth Road southwards for 11m	2
Johns Road	East	From 26m south of the southern kerb-line of Portsmouth Road southwards for 25m	2

**SCHEDULE 3 – Permit parking only 8am-10pm (Deletion)**

Road	Side	Description	Zone
Johns Road	East	From a point 6.5m north of the northern kerb-line of Inkerman Road northwards to a point 52.5m south of the southern kerb-line of Portsmouth Road	2

**SCHEDULE 4 – Permit parking only 8am-10pm (Addition)**

Road	Side	Description	Zone
Johns Road	East	From 6.5m north of the northern kerb-line of Inkerman Road northwards to 51m south of the southern kerb-line of Portsmouth Road	2

**SCHEDULE 5 – Parking limited to 2 hours, except permit holders 8am-10pm, no return within 2 hours (Deletion)**

Road	Side	Description	Zone
Johns Road	East	From a point 10m south of the southern kerb-line of Portsmouth Road southwards for 15m	2
Johns Road	East	From a point 44m south of the southern kerb-line of Portsmouth Road southwards for 8.5m	2
