



**THE CITY OF SOUTHAMPTON (VARIOUS ROADS)
(PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 42) ORDER 2015**

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 13th May 2016 and may be cited as the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 42) Order 2015.

INTERPRETATION

- 2** In this Order:
 - (i) "Principal Order" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

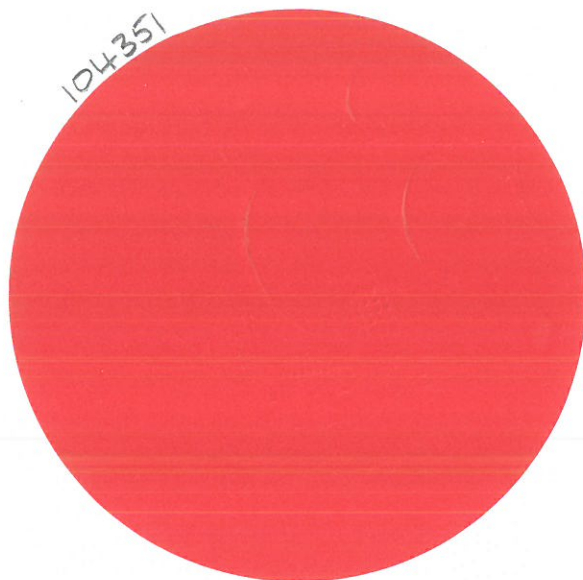
- 3** The contents of schedule 1 shall be deleted from schedule 2.01 of the Principal Order.

Road	Side	Description
Winchester Road	Both	From the eastern kerb-line of Hill Lane eastwards for 73m
Winchester Road	South-east	From a point 7m south-west of the extended south-western kerb-line of Ashwood Gardens north-eastwards to a point 15m north-east of the extended north-eastern kerb-line of Ashwood Gardens

SCHEDULE 2 – No waiting at any time (addition to schedule 2.01)

Road	Side	Description
Winchester Road	North-west	From the eastern kerb-line of Hill Lane eastwards for 73m
Winchester Road	South-east	From the north-eastern kerblines of Ashwood Gardens north-eastwards for 15m
Winchester Road	South-east	From the south-western kerblines of Ashwood Gardens south-westwards for 19m
Winchester Road	South-east	From 52m south-west of the south-western kerblines of Ashwood Gardens south-westwards to the eastern kerblines of Hill Lane

SCHEDULE 3 – Parking Places with 2 Hour Limit (No Return within 2 Hours) 8am - 6pm Monday to Saturday (deletion from schedule 6.05)

Road	Side	Description
Winchester Road	South-east	From a point 7m south-west of the extended south-western kerb-line of Ashwood Gardens south-westwards for 23m
