



**THE CITY OF SOUTHAMPTON (VARIOUS ROADS)
(PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 42) ORDER 2015**

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on 10th June 2016 and may be cited as the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 42) Order 2015.

INTERPRETATION

- 2 In this Order:
- (i) "Principal Order" shall mean The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 Article 8(iii) of the Principal Order shall be deleted and replaced with the following:
- "(iii) (a) Save as provided in sub-paragraphs (d) and (f) below, no person shall cause or permit a vehicle to be left between the hours of 7am and 10am on any day in any part of a parking place specified in Schedule 7.09.
 - (b) Save as provided in sub-paragraphs (d) and (f) below, no person shall cause or permit a vehicle to be left between the hours of 8am and 1pm on any day in any part of a parking place specified in Schedule 7.10.
 - (c) Save as provided in sub-paragraphs (e) and (f) below, no person shall cause or permit a vehicle to be left between the hours of 6am and 6pm Monday to Saturday in any part of a parking place specified in Schedule 7.17.
 - (d) Nothing in sub-paragraphs (a) and (b) above shall apply to a goods vehicle or heavy goods vehicle waiting for the purpose of delivering or collecting goods or merchandise or loading or unloading the vehicle:

PROVIDED THAT the vehicle shall not so wait for a period of more than one hour or if a period of less than one hour has elapsed since the termination of the last period of waiting (if any) of the vehicle in that parking place.
 - (e) Nothing in sub-paragraphs (c) above shall apply to a vehicle waiting for the purpose

of delivering or collecting goods or merchandise or loading or unloading the vehicle:


PROVIDED THAT the vehicle shall not so wait for a period of more than 30 minutes or if a period of less than one hour has elapsed since the termination of the last period of waiting (if any) of the vehicle in that parking place.

- (f) Nothing in sub-paragraphs (a) and (b) above shall prevent any person from causing or permitting a vehicle to wait in any parking place:
 - (I) for so long as may be necessary to enable a person to board or alight from the vehicle;
 - (II) for so long as may be necessary to enable the vehicle to be used in connection with a wedding or funeral provided that the vehicle can be reasonably used for that purpose only from the road;
 - (III) for so long as may be necessary to enable any gate or other barrier at the entrance to premises to which the vehicle requires access or from which it has emerged to be opened or closed;
 - (IV) for so long as may be necessary to enable the vehicle, not being a passenger vehicle, to be used in connection with any of the following operations, if it cannot be so used without waiting in the said road or parking place:
 - building, industrial or demolition operations;
 - the removal of any obstruction to traffic;
 - the maintenance improvement or reconstruction of the said length or road or side of roads;
 - the laying, erection, alteration or repair in or on land adjacent to the said lengths of road or side of roads of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus;
 - the services of a local authority in pursuance of statutory powers or duties;
 - or
 - the posting or removing of advertising material in the form of posters.
 - (V) if the vehicle is being used for police, fire brigade or ambulance purposes;
 - (VI) if the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid an accident; or
 - (VII) if the vehicle is displaying in a prominent position behind the windscreen so that it is facing forwards and can be entirely and easily seen from the front of the vehicle a valid waiver certificate and is waiting in accordance with the terms and conditions prescribed by the said certificate"

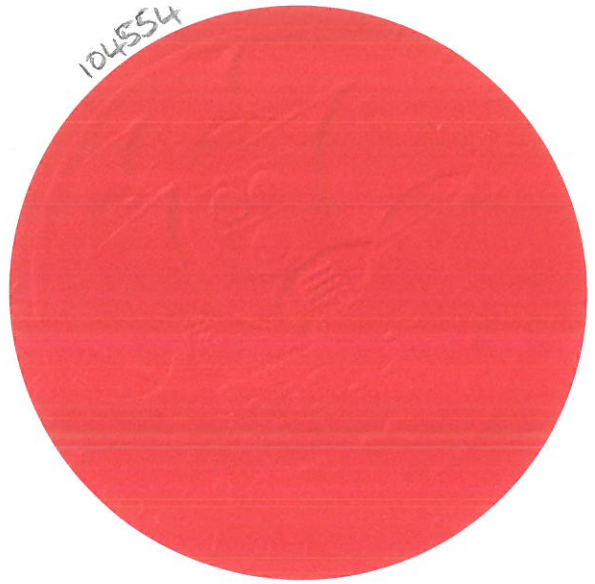
- 4 The contents of schedule 1 shall be deleted from schedule 2.01 of the Principal Order.

- 6 The contents of schedule 3 shall be deleted from schedule 3.11 of the Principal Order.
- 7 The contents of schedule 4 shall be inserted into schedule 6.04 of the Principal Order.
- 8 The contents of schedule 5 shall be inserted into schedule 7.17 of the Principal Order.

SCHEDULE 1 – No waiting at any time (deletion from schedule 2.01)

Road	Side	Description
Kingsclere Avenue	North-west	From the south-western kerb-line of Wallace Road southwards for 71m
Weston Lane	East	From the northern kerb-line of Weston Parade north-eastwards and northwards for 185m
Weston Lane	North-west	From a point 10m north-east of the north-eastern kerb-line of Barnfield Court south-westwards to a point 10m south-west of the extended south-western kerb-line of Camley Close
Weston Lane	South-east	From a point 10m south-west of the south-western kerb-line of Camley Close north-eastwards to a point 10m north-east of the north-eastern kerb-line of Camley Close
Weston Lane	South-east	From a point 15m south-west of the south-western kerb-line of the access to Weston Lane Car Park north-eastwards to a point 75m north-east of the north-eastern kerb-line of Wallace Road
Weston Lane	West	From the northern kerb-line of Weston Parade north-eastwards and northwards to the western kerb-line of Archery Road
Weston Parade	North	From the eastern kerb-line of Weston Lane eastwards for 50m

SCHEDULE 2 – No waiting at any time (addition to schedule 2.01)

Road	Side	Description
Kingsclere Avenue	North-west	From the south-western kerb-line of Wallace Road to 24m south-west of the south-western kerblines of the access road between Kingsclere Avenue and the Weston Lane Parade
Weston Lane	South-east	From a point 75m north-east of the north-eastern kerb-line of Wallace Road south-westwards to a point 5m south-west of the south-western kerblines of Wallace Road
Weston Lane	South-east	From a point 35m south-west of the south-western kerblines of Wallace Road south-westwards for 24m
Weston Lane	South-east	From a point 70m south-west of the south-western kerblines of Wallace Road south-westwards for 4.5m
Weston Lane	South-east	From a point 10m north-east of the north-eastern kerblines of "Road B" south-westwards to a point 10m south-west of the south-western kerb-line of Camley Close
Weston Lane	North-west	From a point 10m north-east of the north-eastern kerb-line of Barnfield Court south-westwards to the extended south-western kerb-line of Squires Walk
South-western access road between Weston Lane and the Weston Lane Parade	Both	For the entire extent of the public highway
North-eastern access road between Weston Lane and the Weston Lane Parade	Both	For the entire extent of the public highway

SCHEDULE 3 – No Loading 8am - 9.30am, 3pm - 5.30pm (deletion from schedule 3.11)

Road	Side	Description
Weston Lane	Both	From a point 10m east of the eastern kerb-line of Wallace Road westwards to a point 25m west of the western kerb-line of Barnfield Road

SCHEDULE 4 – Parking Places with 2 Hour Limit (No Return Same Day) 8am - 6pm Monday to Saturday (addition to schedule 6.04)

Road	Side	Description
Weston Lane	South-east	From a point 59m south-west of the western kerblines of Wallace Road westwards for 11m (angled parking)
Weston Lane	South-east	From a point 74.5m south-west of the western kerblines of Wallace Road westwards a point 10m north-east of the north-eastern kerblines of "Road B (angled parking)

SCHEDULE 5– Loading Only with 30 Minute Limit 6am – 6pm Monday to Saturday (new schedule 7.17)

Road	Side	Description
Weston Lane	South	From to a point 5m south-west of the south-western kerblines of Wallace south-westwards for 30m
