



THE CITY OF SOUTHAMPTON (WAITING RESTRICTIONS AMENDMENT) (PART 1) ORDER 2016

Southampton City Council (hereinafter called “the Council”) in exercise of its powers under sections 1, 2, 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on 17th June 2016 and may be cited as The City of Southampton (Waiting Restrictions Amendment) (Part 1) Order 2016.

INTERPRETATION

- 2 In this Order:
 - (i) “Principal Order 1” means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) “Principal Order 2” means the City of Southampton (Residents Parking) (Zones 1–12 & 16) Order 2014, as amended.
 - (iii) “Principal Order 3” means the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
 - (iv) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (v) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3 The following shall be inserted into Principal Order 2 after Article 20(3):

“Goods Vehicle Loading Bay

20(4) No Vehicle shall wait or be left in a parking place to which a goods vehicle loading bay restriction applies during the Restricted Hours unless that Vehicle is a Goods Vehicle left or waiting for the purpose of loading or unloading.


20(5) No vehicle shall be left in a parking place to which a goods vehicle loading bay restriction applies during the Restrictions Hours for longer than the Maximum Stay.”
- 4 The following shall be inserted into Article 41 of Principal Order 2 after sub-section (viii):

“(ix) to allow the loading/unloading of goods into/from the vehicle provided the loading/unloading is continuous and the vehicles does not wait for more than 30 minutes (this exemption shall not apply to vehicles left or waiting in a length of road to which a no loading restriction applies or in a parking place to which a loading bay or goods vehicle loading bay restriction applies)”
- 5 The contents of schedule 1 shall be deleted from schedule 2.01 of Principal Order 1.
- 6 The contents of schedule 2 shall be inserted into schedule 2.01 of Principal Order 1.
- 7 The contents of Schedule 1.0.1 of Principal Order 2 shall be deleted and replaced with the contents of Schedule 3.

- 8** The contents of Schedule 1.0.3 of Principal Order 2 shall be deleted and replaced with the contents of Schedule 4.
- 9** The contents of schedule 5 shall be deleted from schedule 2.0.1 of Principal Order 2.
- 10** The contents of schedule 6 shall be inserted into schedule 2.0.1 of Principal Order 2.
- 11** The contents of schedule 7 shall be inserted into schedule 3.0.1 of Principal Order 2.
- 12** The contents of Schedule 8 shall be inserted into Principal Order 2 as a new Schedule 11.0.3.
- 13** The contents of schedule 9 shall be inserted into schedule 2.01 of Principal Order 3.
- 14** The contents of schedule 10 shall be deleted from schedule 2.02 of Principal Order 3.
