



**THE CITY OF SOUTHAMPTON (VARIOUS ROADS)
(MOVEMENT RESTRICTIONS) (AMENDMENT 16) EXPERIMENTAL ORDER 2016**

Southampton City Council in exercise of its powers under Sections 9, 10, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION AND COMMENCEMENT

- 1 This Order shall come into operation on 1st August 2016 and may be cited as The City of Southampton (Various Roads) (Movement Restrictions) (Amendment 16) Experimental Order 2016.

EXPERIMENTAL DETAILS

- 2 This Order shall cease to have effect 18 months after it comes into operation, or when a further Order to reproduce and continue in force indefinitely the provisions of this experimental order is made whichever is earliest.
- 3 The Highways Manger may modify or suspend the operation of this order or any provision of it if it appears to them essential:
 - (i) in the interests of the expeditious, convenient and safe movement of traffic,
 - (ii) in the interests of providing suitable and adequate on-street parking facilities, or
 - (iii) for preserving or improving the amenities of the area through which any road affected by the order runs

INTERPRETATION

- 4 In this Order:
 - (i) "Principal Order" shall mean the City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 5 The following shall be inserted in the Principal Order as a new subsection (d) to Article 7:
 - "(d) Save as provided in paragraph (a) of Article 14, no person shall drive or cause or permit to be driven any vehicle on any of the length of road specified in columns 1 and 2 of Schedule 50 otherwise than in the direction specified in column 3 of Schedule 50 during the period specified in column 4 of Schedule 50."

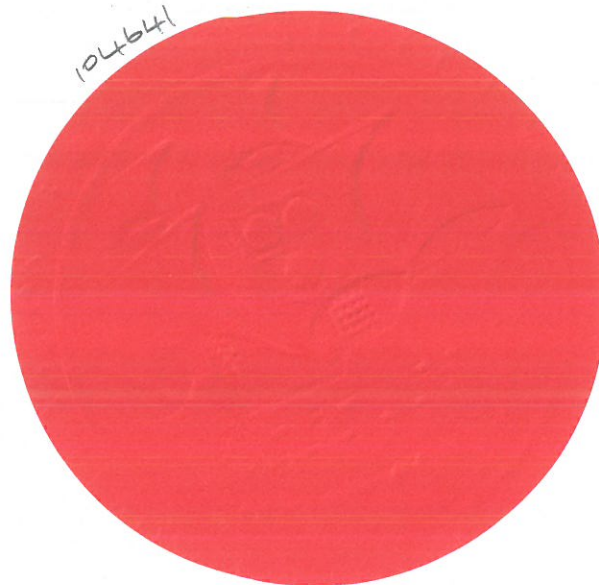
- 6 The following shall be inserted in the Principal Order as a new subsection (p) to Article 10:
“(p) Save as provided in paragraph (a) and (h) of Article 14, no person shall cause or permit any motor vehicle to enter or proceed in any length of road specified in Schedule 51 between 1st August and 31st August.”
- 7 The contents of Schedule 1 shall be deleted from Schedule 12 of the Principal Order.
- 8 The contents of Schedule 2 shall be inserted into the Principal Order as a new Schedule 50.
- 9 The contents of Schedule 3 shall be inserted into the Principal Order as a new Schedule 51.

Road	Description	Direction of Travel	Period of operation
East Street	From its junction with High Street to its junction with Queensway	East	1 st September – 31 st July
East Street	From its junction with High Street to its junction with Back of The Walls	East	1 st August – 31 st August
Back Of The Walls	From its junction with East Street to its junction with Canal Walk (northern east-west spur)	South	1 st August – 31 st August
