



## **THE CITY OF SOUTHAMPTON (ST DENY'S ROAD) (BUS PRIORITY) ORDER 2022**

Southampton City Council in the exercise of its powers under Sections 1, 2, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

### **CITATION**

- 1** This Order shall come into operation on 29<sup>th</sup> May 2023 and may be cited as The City of Southampton (St Deny's Road) (Bus Priority) Order 2022.

### **INTERPRETATION**

- 2** In this Order:
  - (i) "Principal Order" means The City of Southampton (Moving Traffic Restrictions) Order 2022.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

### **AMENDMENTS**

- 3** The contents of Schedule 1 shall be inserted into Schedule 4 to the Principal Order.
- 4** The contents of Schedule 2 shall be deleted from Schedule 8 of the Principal Order.
- 5** The contents of Schedule 3 shall be inserted into Schedule 9 of the Principal Order.
- 6** The contents of Schedule 4 shall be inserted into Schedule 21 of the Principal Order.
