



THE CITY OF SOUTHAMPTON (FIRST CONTROLLED ZONE) (AMENDMENT 13) ORDER 2015

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 26th June 2017 and may be cited as The City of Southampton (First Controlled Zone) (Amendment 13) Order 2015.

INTERPRETATION

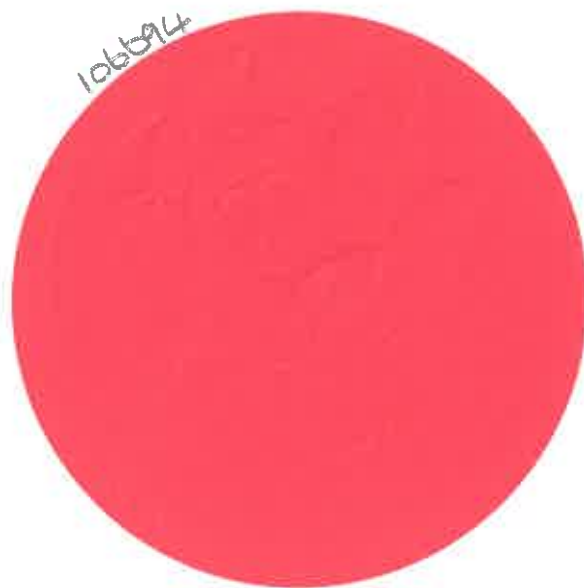
- 2** In this Order:
 - (i) "Principal Order" means the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3** The contents of schedule 1 shall be deleted from schedule 2.02 of the Principal Order.
- 4** The contents of schedule 2 shall be inserted into schedule 2.02 of the Principal Order.
- 5** The contents of schedule 3 shall be deleted from schedule 8.03 of the Principal Order.
- 6** The contents of schedule 4 shall be inserted into schedule 8.03 of the Principal Order.

Road	Side	Description
Brunswick Square	West	From 27m north of the northern kerb-line of Brunswick Square southwards to the southern kerb-line of Brunswick Square
Brunswick Square	West	From 27m south of the southern kerb-line of Bernard Street southwards to 57m north of the northern kerb-line of Brunswick Square
Brunswick Square	West	From 47m north of the northern kerb-line of Brunswick Square southwards for 10m

SCHEDULE 2 – No Waiting 8am - 8pm, Monday to Saturday and 1pm - 6pm Sunday (Addition)

Road	Side	Description
Brunswick Square	West	From the southern kerblines of Brunswick Square to 10.5m north of the northern kerblines of Brunswick Square
Brunswick Square	West	From 55m north of the northern kerblines of Brunswick Square to 27m south of the southern kerblines of Bernard Street

SCHEDULE 3 – Parking Places – Outer Tariff (Grey) (Deletion)

Road	Side	Description	Zone
Brunswick Square	West	From 37m north of the northern kerb-line of Brunswick Square southwards for 10m (max. 2 bays, Parallel) (Zone A)	A
Brunswick Square	West	From 57m north of the northern kerb-line of Brunswick Square southwards to 47m north of the northern kerb-line of Brunswick Square (max. 2 bays, Parallel) (Zone A)	A

SCHEDULE 4 – Parking Places – Outer Tariff (Grey) (Addition)

Road	Side	Description	Zone
Brunswick Square	West	From 10.5m north of the northern kerblines of Brunswick Square northwards for 44.5m (Parallel bays)	A
