



**THE CITY OF SOUTHAMPTON (HIGHFIELD ROAD)
(MOVEMENT & WAITING RESTRICTIONS AMENDMENT) ORDER 2015**

Southampton City Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 10th October 2016 and may be cited as The City of Southampton (Highfield Road) (Movement & Waiting Restrictions Amendment) Order 2015.

INTERPRETATION

- 2** In this Order:
 - (i) "Principal Order 1" shall mean The City of Southampton (Residents Parking) (Zones 1–12 & 16) Order 2014, as amended.
 - (ii) "Principal Order 2" shall mean The City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

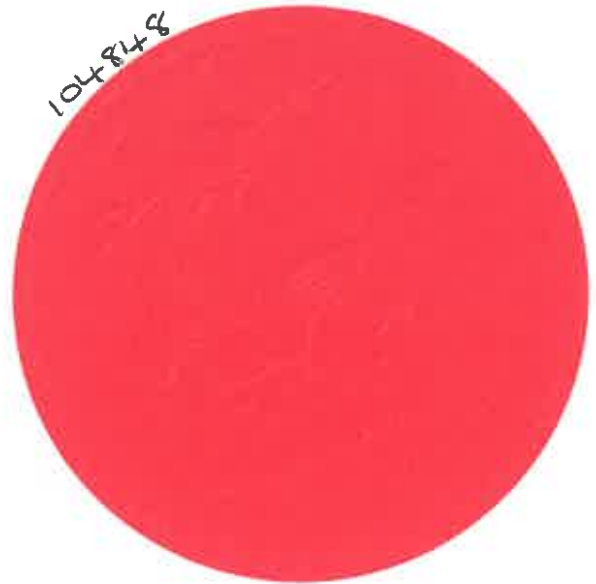
- 3** The contents of schedule 1 shall be deleted from schedule 2.0.1 of Principal Order 1.
