



**THE CITY OF SOUTHAMPTON
(WAITING RESTRICTIONS AMENDMENT) (PART 2) ORDER 2015**

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on 29th August 2016 and may be cited as The City of Southampton (Waiting Restrictions Amendment) (Part 2) Order 2015.

INTERPRETATION

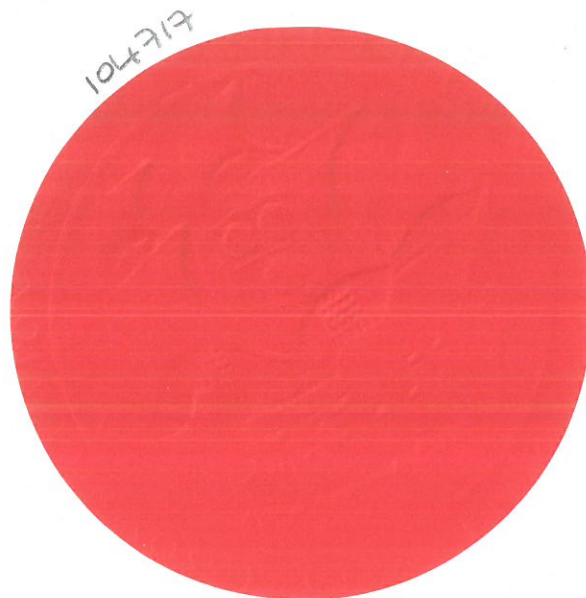
- 2 In this Order:
 - (i) "Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3 The contents of schedule 1 shall be deleted from schedule 2.01 of the Principal Order.
- 4 The contents of schedule 2 shall be added to schedule 2.01 of the Principal Order.

SCHEDULE 1 – No Waiting at Any Time (2.01 - Deletion)

Road	Side	Description
Botley Road	Both	From a point 10m north-east of the north-eastern boundary fence of No. 267 north-eastwards for 47m
Botley Road	North	From the north-eastern kerb-line of Bursledon Road northwards for 10m
Botley Road	South	From the north-eastern kerb-line of Bursledon Road north-eastwards for 15m

SCHEDULE 2 – No Waiting at Any Time (2.01 - Addition)

Road	Side	Description
Botley Road	North	From the north-eastern kerblines of Bursledon Road north-eastwards for 63m
Botley Road	North	From 10m north-east of the north-eastern boundary fence of 267 Botley Road north-eastwards for 47m
Botley Road	South	From the north-eastern kerblines of Bursledon Road north-eastwards for 142m
Willis Road	Both	From the eastern kerblines of Stoneham Lane eastwards for 10m
Stoneham Lane	East	From 10m south of the southern kerblines of Willis Road to 10m north of the northern kerblines of Willis Road
Winchester Road	South-east	From opposite the boundary between 434/436 Winchester Road north-eastwards for 50m
