

THE CITY OF SOUTHAMPTON (WAITING RESTRICTIONS AMENDMENT) (PART 2) ORDER 2016

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2, 4, 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

1 This Order shall come into operation 29th August 2016 and may be cited as The City of Southampton (Waiting Restrictions Amendment) (Part 2) Order 2016.

INTERPRETATION


- 2 In this Order:
 - (i) "Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3 The contents of schedule 1 shall be added to schedule 2.01 of the Principal Order.
- 4 The contents of schedule 2 shall be added to schedule 4.15 of the Principal Order.

Bitterne Road East	South	From 10m east of its junction with Bitterne Road East (Service Road) to 10m west of this junction
Bitterne Road East (Service Road)	Both	From 10m east to 10m west of its junction with Bitterne Road East and both sides of the junction
Bitterne Road East (Service Road)	South	From 10m west of the western kerbline of Milbury Crescent eastwards to 10m east of eastern kerbline of Milbury Crescent
Glenfield Crescent	West	From 10m south of the southern kerbline of Glenfield Way northwards to 10m north of the northern kerbline of Glenfield Way
Glenfield Way	Both	From the western kerbline of Glenfield Crescent north- westwards for 10m
Milbury Crescent	Both	From the southern kerbline of Bitterne Road East (Service Road) southwards for 10m
