

THE CITY OF SOUTHAMPTON (GOLDEN GROVE) ORDER 2019

Southampton City Council in exercise of its powers under Sections 1, 2, 35, 45, 46, 49 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the 1984 Act) and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 of the 1984 Act hereby makes the following Order:

PART ONE - INTRODUCTION

COMMENCEMENT AND CITATION

1.1 This order shall come into operation on the 1st October 2020 and may be cited as The City of Southampton (Golden Grove) Order 2019.

INTERPRETATION

- 1.2 In this Order, except where otherwise stated, any reference to an article, schedule or part shall be construed as a reference to that article, schedule or part in this Order.
- 1.3 In this Order any reference to an Act, Statutory Instrument or Order shall be construed as a reference to that Act, Statutory Instrument or Order as amended.
- 1.4 Where any provision of this Order conflicts with the effect of the prohibition specified in Schedule 7, Part 6 Paragraph 1 of the TSRGD (bus stop clearway), the effect of prohibition specified in Schedule 7, Part 6 Paragraph 1 of the TSRGD shall take precedence.
- 1.5 Where any provision of this Order conflicts with the effects of article 3.14 (on-street disabled badge holder parking), the effects of article 3.14 shall take precedence.
- 1.6 In this Order the following expressions shall have the respective meanings assigned to them:
 - "Civil Enforcement Officer" means a person authorised by or on behalf of the Council in accordance with the provisions of Part 6 of the Traffic Management Act 2004 to enforce the restrictions imposed by this Order.
 - "Council" means Southampton City Council.
 - "Disabled Persons Vehicle" means a vehicle displaying a valid disabled persons badge in accordance with The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000.
 - "Motor Vehicle" means a mechanically propelled vehicle constructed or adapted for use on roads.
 - "Parking Permit" means a parking permit issued by the Council under part 5 of this Order.
 - "Permit Entitlement Register" means the database managed by the Council which specifies the type and number of Parking Permits a property is eligible for, in accordance with the Councils Residents Parking Policy.
 - "TSRGD" means the Traffic Signs Regulations and General Directions 2016.

PART TWO - PROHIBITION OF WAITING AND LOADING

NO WAITING AT ANY TIME

- 2.1 No person shall cause or permit any vehicle to wait in the lengths of road specified in Columns 1, 2 and 3 of schedule 1.
- 2.2 Nothing in article 2.1 shall apply to a vehicle waiting in the following circumstances:

- (a) to allow the picking up or setting down of passengers.
- (b) to allow the opening or closing of a gate or barrier at an entrance which the vehicle requires access to or has just exited.
- (c) the vehicle is being used in connection with any building, industrial or demolition operations, the removal of any obstruction of traffic, the maintenance improvement or reconstruction of the road, the laying, erection, alteration or repair of any sewer, or of any main, pipe or apparatus, for the supply of gas, water or electricity or of any telecommunications apparatus where the vehicle cannot be conveniently used for this purpose in any other place.
- (d) the vehicle is being used by or on behalf of the Council in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
- (e) the vehicle is being used by or on behalf of a Statutory Undertaker in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
- (f) the vehicle is being used in connection with a wedding or funeral where the vehicle cannot be conveniently used for this purpose in any other place.
- (g) the vehicle is waiting for the purposes of loading or unloading, provided the loading/unloading is continuous, being undertaken in a timely manner and the vehicle does not wait for a period of more than 30 minutes.
- (h) the vehicle is a Disabled Persons Vehicle, provided the Disabled Persons Vehicle does not wait for longer than three hours and at least one hour has elapsed following a previous period of waiting by the Disabled Persons Vehicle in the same length of a road.

NO WAITING DURING RESTRICTED HOURS

- 2.3 No person shall cause or permit any vehicle to wait in the lengths of road specified in columns 1, 2 and 3 of schedule 2 during the hours specified in column 4 of schedule 2.
- 2.4 Nothing in article 2.3 shall apply to a vehicle waiting in the following circumstances:
 - (a) to allow the picking up or setting down of passengers.
 - (b) to allow the opening or closing of a gate or barrier at an entrance which the vehicle requires access to or has just exited.
 - (c) the vehicle is being used in connection with any building, industrial or demolition operations, the removal of any obstruction of traffic, the maintenance improvement or reconstruction of the road, the laying, erection, alteration or repair of any sewer, or of any main, pipe or apparatus, for the supply of gas, water or electricity or of any telecommunications apparatus where the vehicle cannot be conveniently used for this purpose in any other place.
 - (d) the vehicle is being used by or on behalf of the Council in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
 - (e) the vehicle is being used by or on behalf of a Statutory Undertaker in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
 - (f) the vehicle is being used in connection with a wedding or funeral where the vehicle cannot be conveniently used for this purpose in any other place.
 - (g) the vehicle is waiting for the purposes of loading or unloading, provided the loading/unloading is continuous, being undertaken in a timely manner and the vehicle does not wait for a period of more than 30 minutes.
 - (h) the vehicle is a Disabled Persons Vehicle, provided the Disabled Persons Vehicle does not wait for longer than three hours and at least one hour has elapsed following a previous period of waiting by the Disabled Persons Vehicle in the same road or length of a road.

DESIGNATION OF PARKING PLACES

- 3.1 The lengths of road specified in columns 1, 2 and 3 of schedule 3, having a width as indicated by the road markings, or in the case of signed only areas a width that extends from the centre of the carriageway to the back of the highway, are designated as parking places (hereinafter referred to as "on-street parking places").
- 3.2 The lengths of road indicated by a road marking to schedule 7, Part 4, Item 6 of the TSRGD, and/or a sign to schedule 1, Part 4, Item 6 of the TSRGD as being reserved for use by disabled badge holders are designated as parking places (hereinafter referred to as "on-street parking places").

USE OF PARKING PLACES

- 3.3 A vehicle left in an on-street parking place must be parked wholly within the boundaries of the on-street parking place.
- 3.4 No vehicle left in an on-street parking place shall be left in a position which prevents access to any premises or which obstructs the passage of traffic (including pedestrians).
- 3.5 The driver of a Motor Vehicle using an on-street parking place must stop the engine as soon as the vehicle is in position and must not start the engine except to change the position of the vehicle or depart from the on-street parking place.
- 3.6 Unless the prior written consent of the Council is obtained no vehicle left in an on-street parking place shall be used in connection with the sale of any goods or services except where goods (including postal parcels) are being delivered to any premises in the immediate area.

SUSPENSION OF PARKING PLACES

- 3.7 The Council or any person so authorised by the Council may suspend use of any on-street parking place or part of an on-street parking place.
- 3.8 No person shall cause or permit any vehicle to wait in an on-street parking place which has been suspended.

REMOVAL OF VEHICLES

- 3.9 Where a vehicle is in contravention of article 3.4 or article 3.8 the Council or any person so authorised by the Council or a Police Officer in uniform or a Civil Enforcement Officer may remove the vehicle or arrange for the vehicle to be removed from the on-street parking place in any manner as they consider necessary.
- 3.10 Any person removing or arranging for a vehicle to be removed under article 3.9 must make such arrangement as reasonably necessary for the reasonable safe custody of that vehicle.

PERMIT PARKING OR LIMITED WAITING

- 3.11 No person shall cause or permit any vehicle to wait in the on-street parking places specified in columns 1, 2 and 3 of schedule 3 during the hours specified in column 4 of schedule 3 for longer than the period of time specified in column 5 of schedule 3 unless that vehicle is displaying a valid Parking Permit for the zone specified in column 7 of schedule 3.
- 3.12 No person shall cause or permit any vehicle waiting in the on-street parking places specified in columns 1, 2 and 3 of Schedule 3 during the hours specified in column 4 of schedule 3 to return to any Zone 17 parking place within the period of time specified in column 6 of schedule 3 unless that vehicle is displaying a valid Parking Permit for the zone specified in column 7 of schedule 3.
- 3.13 Nothing in articles 3.11 or 3.12 shall apply to a vehicle waiting or left in the following circumstances:
 - (a) to allow the picking up or setting down of passengers.
 - (b) to allow the opening or closing of a gate or barrier at an entrance which the vehicle requires access to or has just exited.
 - (c) the vehicle is being used in connection with any building, industrial or demolition operations, the removal of any obstruction of traffic, the maintenance improvement or reconstruction of the road, the laying, erection, alteration or repair of any sewer, or of any main, pipe or apparatus, for the

- supply of gas, water or electricity or of any telecommunications apparatus where the vehicle cannot be conveniently used for this purpose in any other place.
- (d) the vehicle is being used by or on behalf of the Council in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
- (e) the vehicle is being used by or on behalf of a Statutory Undertaker in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
- (f) the vehicle is a Disabled Persons Vehicle.

DISABLED BADGE HOLDER PARKING

- 3.14 No person shall cause or permit any vehicle other than a Disabled Persons Vehicle to wait or be left in the on-street parking places indicated by the road marking to schedule 7, Part 4, Item 6 of the TSRGD, and/or a sign to schedule 4, Part 5, Item 4 of the TSRGD as being reserved for use by disabled badge holders.
- 3.15 Nothing in article 3.14 shall apply to a vehicle waiting or left in the following circumstances:
 - (a) to allow the picking up or setting down of passengers.
 - (b) to allow the opening or closing of a gate or barrier at an entrance which the vehicle requires access to or has just exited.
 - (c) the vehicle is being used in connection with any building, industrial or demolition operations, the removal of any obstruction of traffic, the maintenance improvement or reconstruction of the road, the laying, erection, alteration or repair of any sewer, or of any main, pipe or apparatus, for the supply of gas, water or electricity or of any telecommunications apparatus where the vehicle cannot be conveniently used for this purpose in any other place.
 - (d) the vehicle is being used by or on behalf of the Council in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
 - (e) the vehicle is being used by or on behalf of a Statutory Undertaker in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.

PART FOUR - OFF-STREET PARKING PLACES

DESIGNATION OF OFF-STREET PARKING PLACES

4.1 The areas specified in column 1 (with reference to the plan provided in schedule 5) and column 2 of schedule 4 are designated as parking places (hereinafter referred to as "off-street parking places").

USE OF OFF-STREET PARKING PLACES

- 4.2 A vehicle left in an off-street parking place must be parked wholly within a marked parking bay (if provided).
- 4.3 No vehicle other than a Disabled Persons Vehicle shall be left within a parking bay in an off-street parking place which is marked and/or signed as being for use by Disabled Persons Vehicles. For the avoidance of doubt a valid a valid Parking Permit must also be displayed.
- 4.4 No vehicle other than an Electric Vehicle being recharged shall be left within a parking bay in an offstreet parking place which is marked and/or signed as being for recharging Electric Vehicles.
- 4.5 Where a parking bay or area in an off-street parking place is marked and/or signed as being for use by a specific vehicle or class of vehicle, no other vehicle or vehicle not of that class shall be left within that parking bay or area.
- 4.6 No vehicle left in an off-street parking place shall be left in a position which prevents access or which obstructs other vehicles or pedestrians.
- 4.7 The driver of a Motor Vehicle using an off-street parking place must stop the engine as soon as the Motor Vehicle is in position and must not start the engine except to change the position of the Motor Vehicle or depart from the off-street parking place.

4.8 Unless the prior written consent of the Council is obtained no vehicle left in an off-street parking place shall be used in connection with the sale of any goods or services except where goods (including postal parcels) are being delivered to any premises in the immediate area.

SUSPENSION OF OFF-STREET PARKING PLACES

- 4.9 The Council or any person so authorised by the Council may suspend use of any off-street parking place or part of an off-street parking place.
- **4.10** No person shall cause or permit any vehicle to wait in an off-street parking place or part of an off-street parking place which has been suspended.

REMOVAL OF VEHICLES

- 4.11 Where a vehicle is in contravention of article 4.6 or article 4.10 the Council or any person so authorised by the Council or a Police Officer in uniform or a Civil Enforcement Officer may remove the vehicle or arrange for the vehicle to be removed from the off-street parking in any manner as they consider necessary.
- 4.12 Any person removing or arranging for a vehicle to be removed under article 4.11 must make such arrangement as reasonably necessary for the reasonable safe custody of that vehicle.

PERMIT PARKING (OFF-STREET)

- 4.13 No person shall cause or permit any vehicle to wait or be left in the off-street parking places specified in column 1 (with reference to the plan provided in schedule 5) and column 2 of schedule 4, during the hours specified in column 3 of schedule 4, unless that vehicle is displaying a valid Parking Permit for the zone specified in column 4 of schedule 4.
- **4.14** Nothing in article 4.13 shall apply to a vehicle waiting or left in the following circumstances:
 - (a) to allow the picking up or setting down of passengers.
 - (b) to allow the opening or closing of a gate or barrier at an entrance which the vehicle requires access to or has just exited.
 - (c) the vehicle is being used in connection with any building, industrial or demolition operations, the removal of any obstruction of traffic, the maintenance improvement or reconstruction of the road, the laying, erection, alteration or repair of any sewer, or of any main, pipe or apparatus, for the supply of gas, water or electricity or of any telecommunications apparatus where the vehicle cannot be conveniently used for this purpose in any other place.
 - (d) the vehicle is being used by or on behalf of the Council in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.
 - (e) the vehicle is being used by or on behalf of a Statutory Undertaker in pursuance of a statutory power or duty where the vehicle cannot be conveniently used for this purpose in any other place.

PART FIVE -- PARKING PERMITS

ELIGIBILITY FOR PARKING PERMITS

5.1 Any person, partnership or body corporate who meets the criteria specified in column 4 of schedule 6 shall be eligible for a Parking Permit of the type specified in column 1 of schedule 6.

APPLICATION FOR PARKING PERMITS

- 5.2 An application for a Parking Permit must be made in the manner specified by the Council.
- 5.3 The Council may require an applicant to produce such evidence as considered necessary to verify the information provided as part of the application for a Parking Permit.

ISSUE OF PARKING PERMITS

5.4 On receipt of an application for a Parking Permit and payment of any relevant charge, the Council upon being satisfied that the applicant is eligible and meets all relevant requirements may issue a Parking Permit.

- 5.5 The charge for the issue of each Parking Permit shall be as specified in column 2 of schedule 6, valid for the length of time specified in column 3 of schedule 6.
- 5.6 A duplicate Parking Permit may be issued by the Council if the original Parking Permit has been lost, stolen, or becomes mutilated, defaced, faded discoloured or otherwise illegible.
- 5.7 There will be a charge of £13.00 for the issue of each duplicate Parking Permit.
- 5.8 The Council reserves the right to vary the policy, charges and terms for the issue of a Parking Permit as it considers appropriate and may provide written notice of any such variation as it considers appropriate.
- 5.9 Notwithstanding the preceding articles, the issuing of Parking Permits is at the complete discretion of the Council and exceptionally Parking Permits may be issued as the Council considers appropriate.

VALIDITY OF PARKING PERMITS

- **5.10** A Parking Permit shall only be valid for use within the zone(s) in respect of which it was issued and when used in accordance with the conditions of use specified in column 5 of schedule 6.
- 5.11 A Parking Permit shall cease to be valid in the following circumstances:
 - (a) After the expiry date specified on it,
 - (b) The Parking Permit holder ceases to be eligible for the Parking Permit,
 - (c) The withdrawal of the Parking Permit by the Council,
 - (d) A duplicate Parking Permit is issued by the Council.

WITHDRAWAL AND SURRENDER OF PARKING PERMITS

- 5.12 A Parking Permit holder may surrender a Parking Permit to the Council at any time.
- **5.13** A Parking Permit holder must surrender a Parking Permit to the Council in the circumstances specified in article 5.11.
- 5.14 The Council may serve notice of the withdrawal of a Parking Permit in writing to the Parking Permit holder at the address given on the application or at any other address believed to be the parking permit holders residence or place of business; on receipt of this notice the Parking Permit holder shall surrender the Permit to the Council within 14 days.

FORM OF PARKING PERMITS

- 5.15 A Parking Permit shall be in writing and shall include the following particulars:
 - (a) An indication of the location or locations where the Parking Permit is valid for use
 - (b) The expiry date of the Parking Permit
 - (c) An indication that the Parking Permit was issued by the Council

DISPLAY OF PARKING PERMITS

5.16 A Parking Permit must be displayed in the case of a vehicle fitted with a transparent windscreen on the inside surface of the windscreen so that it is facing upwards and can be entirely and easily seen from outside the vehicle or in the case of a vehicle not fitted with a transparent windscreen, in a conspicuous position on the vehicle.

PART SIX - OTHER EXEMPTIONS

GENERAL EXEMPTIONS

6.1 Nothing in this Order shall prohibit any vehicle from waiting for as long as necessary in the following circumstances:

- (a) The vehicle is directed to wait or stop by or with the permission of a Police Officer in uniform or Civil Enforcement Officer
- (b) The vehicle is being used for fire and rescue (within the meaning of the Fire and Rescue Services Act 2004), ambulance (including providing a response to an emergency at the request of an NHS ambulance service), bomb or explosive disposal, special forces, police or National Crime Agency purposes and the observance of a provision of this order would be likely to hinder the use of that vehicle for the purpose for which it is being used
- (c) Where the vehicle is prevented from proceeding by circumstances beyond the drivers control or in order to prevent an accident
- (d) The vehicle cannot be moved due to an unavoidable breakdown.

PART SEVEN - CONTRAVENTION & REVOCATIONS

CONTRAVENTION

7.1 Any person or vehicle failing to comply with the provisions of this Order shall be in contravention of it and a penalty charge shall be payable.

REVOCATIONS

- 7.2 The contents of schedule 7 shall be deleted from schedule 2.01 of The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011.
- 7.3 The contents of schedule 8 shall be deleted from schedule 2.01 of the City of Southampton (First Controlled Zone) Traffic Regulation Order 2012.


