

THE CITY OF SOUTHAMPTON (MEMBER MINOR WORKS) (NO.2) ORDER 2020

Southampton City Council in exercise of its powers under Sections 1, 2, 32 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 24th May 2021 and may be cited as The City of Southampton (Member Minor Works) (No. 2) Order 2020.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011.
 - (ii) "Principal Order 2" means the City of Southampton (Residents Parking) (Zones 1-12 & 16) Order 2014.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The contents of Schedule 1 shall be deleted from Schedule 2.0.1 of Principal Order 1.
- 4 The contents of Schedule 2 shall be inserted into Schedule 2.0.1 of Principal Order 1.
- 5 The contents of Schedule 3 shall be inserted into Schedule 2.14 of Principal Order 1.
- 6 The contents of Schedule 4 shall be deleted from Schedule 6.18 of Principal Order 1.
- 7 The contents of Schedule 5 shall be inserted into Schedule 6.2.4 of Principal Order 2.
