

THE CITY OF SOUTHAMPTON (NORTHERN RING ROAD) (PART 1) ORDER 2021

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

This Order shall come into operation on 19th November 2021 and may be cited as The City of Southampton (Northern Ring Road) (Part 1) Order 2021.

INTERPRETATION

- 2 In this Order:
 - (i) "Principal Order 1" means The City of Southampton (Various Roads) (Movement Restrictions) Traffic Regulation Order 2010, as amended.
 - (ii) "Principal Order 2" means The City of Southampton (First Controlled Zone) Traffic Regulation Order 2012, as amended.
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3 The contents of Schedule 1 shall be added to Schedule 10 of Principal Order 1.
- 4 The contents of Schedule 2 shall be added to Schedule 11 of Principal Order 1.
- 5 The contents of Schedule 3 shall be deleted from Schedule 2.01 of Principal Order 2.
