



THE CITY OF SOUTHAMPTON (PEARTREE) ORDER 2023

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 6th November 2023 and may be cited as The City of Southampton (Peartree) Order 2023

INTERPRETATION

- 2** In this Order:
 - (i) "Principal Order 1" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
 - (ii) "Principal Order 2" means the City of Southampton (Residents Parking) (Zones 1-12&16) Order 2014, as amended
 - (iii) "Principal Order 3" means the City of Southampton (Moving Traffic Restrictions) Order 2022, as amended
 - (iv) "Principal Order 4" means the City of Southampton (Northam, Bitterne Manor & Itchen) (Residents' Parking Scheme) Order 2008, as amended
 - (v) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (vi) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3** The contents of Schedule 1 shall be added to Schedule 2.01 to the Principal Order 1.
- 4** The contents of Schedule 2 shall be added to Schedule 2.0.1 to the Principal Order 2.
- 5** The contents of Schedule 3 shall be deleted from Schedule 9 to the Principal Order 3.
- 6** The contents of Schedule 4 shall be added to Schedule 7 to the Principal Order 3.
- 7** The contents of Schedule 5 shall be deleted from Schedule 2.04 to the Principal Order 4.

Schedule 1 – No waiting at any time (Addition to Schedule 2.01) (Principal Order 1)

Road	Side	Description
Bishops Road	North-west	From the southern kerbline of Sholing Road, south-westwards for 20m
Bishops Road	South-east	From the southern kerbline of Sholing Road, south-westwards for 40m
Knighton Road	West	From the south-eastern kerbline of Bishops Road, southwards for 24m
Knighton Road	East	From the south-eastern kerbline of Bishops Road, southwards for 30m
Sea Road	North	From the eastern kerbline of Hazel Road eastwards for 75m
Sholing Road	South	From 36m west of western kerbline of Bishops Road to 14m east of the eastern kerbline of Bishops Road

Schedule 2 – No waiting at any time (Addition to Schedule 2.0.1) (Principal Order 2)

Road	Side	Description	Zone
Archery Road	North-east	From the south-eastern kerbline of Swift Road, south-eastwards for 10m	3
Swift Road	South	From the eastern kerbline of Weston Grove Road, eastwards for 52m	3

Sea Road	From 7m east of the eastern kerbline of Hazel Road eastwards for 61m	All	1 - For access	Thorneycroft



Sea Road	North	From the eastern kerbline of Hazel Road eastwards for a distance of 75m
