

# THE CITY OF SOUTHAMPTON (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 87) ORDER 2023

Southampton City Council in exercise of its powers under Sections 1, 2, 32 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

### **CITATION**

This Order shall come into operation on 14<sup>th</sup> August 2023 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 87) Order 2023.

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

#### **AMENDMENTS**

- 3 The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order.
- 4 The contents of Schedule 2 shall be inserted into Schedule 2.01 to the Principal Order
- 5 The contents of Schedule 3 shall be deleted from Schedule 6.05 to the Principal Order.
- 6 The contents of Schedule 4 shall be inserted into Schedule 6.05 to the Principal Order.
