



**THE CITY OF SOUTHAMPTON  
(PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 87) ORDER 2023**

Southampton City Council in exercise of its powers under Sections 1, 2, 32 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

**CITATION**

- 1 This Order shall come into operation on 14<sup>th</sup> August 2023 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 87) Order 2023.

**INTERPRETATION**

- 2 In this Order:
- (i) "Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

**AMENDMENTS**

- 3 The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order.
- 4 The contents of Schedule 2 shall be inserted into Schedule 2.01 to the Principal Order
- 5 The contents of Schedule 3 shall be deleted from Schedule 6.05 to the Principal Order.
- 6 The contents of Schedule 4 shall be inserted into Schedule 6.05 to the Principal Order.

**Schedule 1 – No Waiting at any time (Deletion from Schedule 2.01 of the Principal Order)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Woodmill Lane	North	From a point opposite the boundary of numbers 319/321 Woodmill Lane eastwards to a point opposite number 315 Woodmill Lane
Woodmill Lane	North	From the eastern kerb-line of High Road eastwards to a point opposite the boundary of numbers 321/323 Woodmill Lane
Woodmill Lane	South	From the boundary of numbers 327/329 Woodmill Lane to the boundary of numbers 317/319 Woodmill Lane

**Schedule 2 – No Waiting at any time (Addition to Schedule 2.01 of the Principal Order)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Woodmill Lane	North and north-east	From the eastern kerb-line of High Road eastwards to 3.5 metres south of the extended property boundary of 315 Woodmill Lane and 313 Woodmill Lane
Woodmill Lane	South and south-west	From the 6m west of 327 Woodmill Lane and 329 Woodmill Lane to the boundary between 315 Woodmill Lane and 313 Woodmill Lane

**Schedule 3 – Parking Places with 2 Hour Limit (No Return within 2 Hours) 8am - 6pm Monday to Saturday (Deletion from Schedule 6.05 to the Principal Order)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Woodmill Lane	North	From a point opposite the boundary of numbers 321/323 Woodmill Lane eastwards to a point opposite the boundary of numbers 319/321 Woodmill Lane
Woodmill Lane	West	From the boundary of numbers 317/319 Woodmill Lane to the north side of the driveway of number 303 Woodmill Lane
Woodmill Lane	South	From a point outside number 333 Woodmill Lane eastwards to the boundary of numbers 327/329 Woodmill Lane

**Schedule 4 - Parking Places with 2 Hour Limit (No Return within 2 Hours) 8am - 6pm Monday to Saturday (Addition to Schedule 6.05 of the Principal Order)**

<b>Road</b>	<b>Side</b>	<b>Description</b>
Woodmill Lane	South-west	From the boundary of 315 Woodmill Lane and 313 Woodmill Lane southwards for 50m
Woodmill Lane	South	From 6m west of 327 Woodmill Lane and 329 Woodmill Lane, westwards for 17m
