

THE CITY OF SOUTHAMPTON (WAITING RESTRICTIONS AMENDMENT) (PART B) ORDER 2022

Southampton City Council in exercise of its powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

1 This Order shall come into operation on 12th June 2023 and may be cited as The City of Southampton (Waiting Restrictions Amendment) (Part B) Order 2022.

INTERPRETATION

- 2 In this Order:
 - "The Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011.
 - (ii) amended by any subsequent enactments.

AMENDMENTS

3 The contents of Schedule 2 shall be added to Schedule 2.01 of The Principal Order.
