



THE CITY OF SOUTHAMPTON (WOOLSTON & ITCHEN ATZ) ORDER 2022

Southampton City Council in exercise of its powers under Sections 1, 2, 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

CITATION

- 1** This Order shall come into operation on 13th March 2023 and may be cited as The City of Southampton (Woolston & Itchen ATZ) Order 2022.

INTERPRETATION

- 2** In this Order:
 - (i) "Principal Order 1" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
 - (ii) "Principal Order 2" means the City of Southampton (Residents Parking) (Zones 1-12&16) Order 2014, as amended
 - (iii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iv) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 3** The contents of Schedule 1 shall be deleted from Schedule 2.01 to the Principal Order 1.
- 4** The contents of Schedule 2 shall be inserted into Schedule 2.01 to the Principal Order 1.
- 5** The contents of Schedule 3 shall be deleted from Schedule 2.0.1 to the Principal Order 2.
- 6** The contents of Schedule 4 shall be inserted into Schedule 2.0.1 to the Principal Order 2.
- 7** The contents of Schedule 5 shall be deleted from Schedule 6.1.3 to the Principal Order 2
- 8** The contents of Schedule 6 shall be deleted from Schedule 6.1.4 to the Principal Order 2.
- 9** The contents of Schedule 7 shall be inserted into Schedule 6.1.4 to the Principal Order 2.

Radstock Road	South	From a point 15m west of the western kerb-line of Manor Road South eastwards to a point 15m east of the eastern kerb-line of Manor Road South
Radstock Road	South	From a point 10m west of its junction with Cheddar Close to a point 10m east of that junction
Manor Road South	Both	From the southern kerb-line of Radstock Road southwards for 15m
