

# THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHBITION AND RESTRICTION OF WAITING) (AMENDMENT 50) ORDER 2017

Southampton City Council in exercise of its powers under Sections 1, 2, 4, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to that Act hereby makes the following Order:

#### **CITATION**

This Order shall come into operation on 1<sup>st</sup> December 2017 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 50) Order 2017.

#### INTERPRETATION

- 2 In this Order:
  - (i) "Principal Order" shall mean the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

#### **ADDITION/AMENDMENT OF SCHEDULES**


- 3 The contents of schedule 1 shall be deleted from schedule 2.01 of the Principal Order.

### **SCHEDULE 1** – No waiting at any time (Deletion from schedule 2.01)

Road	Side	Description
Regent's Park Road	North- west	From a point 10m south-west of the south-western kerb-line of Claremont Crescent (south) north-eastwards to a point 10m north-east of the north-eastern kerb-line of Claremont Crescent
Regent's Park Road	East and South- east	From the northern boundary of number 36 Regent's Park Road northwards and north-eastwards to the south-western boundary of number 40 Regent's Park Road

## SCHEDULE 2 - No waiting at any time (Addition from schedule 2.01)

Road	Side	Description
Regent's Park Road	North- west	From 10m south-west of the south-western kerb-line of Claremont Crescent (southern junction) north-eastwards to 15m north-east of the north-eastern kerb-line of Claremont Crescent (southern junction)
Regent's Park Road	East and South- east	From the boundary between 34 Regent's Park Road and 36 Regent's Park Road north-eastwards to the south-western boundary of 40 Regents Park Road
