



THE CITY OF SOUTHAMPTON (VARIOUS ROADS) (PROHIBITION AND RESTRICTION OF WAITING) (AMENDMENT 64) ORDER 2018

Southampton City Council (hereinafter called "the Council") in exercise of its powers under sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Office of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

CITATION

- 1 This Order shall come into operation on 30th January 2019 and may be cited as The City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) (Amendment 64) Order 2018.

INTERPRETATION

- 2 In this Order:
- (i) "Principal Order" means the City of Southampton (Various Roads) (Prohibition and Restriction of Waiting) Traffic Regulation Order 2011, as amended.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
- 3 The contents of Schedule 1 shall be added to Schedule 2.01 to the Principal Order

SCHEDULE 1 – No Waiting at any Time (Schedule 2.01 - addition)

Road	Side	Description
Cuckmere Lane	North	From a point 10 metres east of the eastern kerbline of Studland Road westwards to the western extent of the adopted highway
Cuckmere Lane	South	From a point 10 metres east of the eastern kerbline of Studland Road westwards to a point 11.5 metres west of the western kerbline of Studland Road
Cuckmere Lane	South	From a point 18.5 metres west of the western kerbline of Studland Road westwards for 38 metres
Cuckmere Lane	South	From a point 75.5 metres west of the western kerbline of Studland Road westwards for 2 metres
Cuckmere Lane	South	From a point 85 metres west of the western kerbline of Studland Road westwards for 16.5 metres
Cuckmere Lane	South	From a point 111 metres west of the western kerbline of Studland Road westwards for 23 metres
Cuckmere Lane	South	From a point 149m west of the western kerbline of Studland Road westwards to the western extent of the adopted highway
Cuckmere Lane	West	From a point 4 metres north-east of the north eastern flank wall of Redbridge Towers northwards to the northern kerbline of Cuckmere Lane
Cuckmere Lane	Both	From a point 7 metres south of the north eastern flank wall of Redbridge Towers southwards for 2 metres
Cuckmere Lane	East	From a point 17.5 metres south of the north eastern flank wall of Redbridge Towers southwards to a point 2.5 metres west of the north-western flank wall of Nos 133-163 Cuckmere Lane
Cuckmere Lane	South	From the exit to Redbridge Towers car park eastwards for 13 metres
