(AMENDMENT NO. 1 ORDER 2002)

The Southend-on-Sea Borough Council, in exercise of its powers under Section 35 of the Road Traffic Regulation Act 1984 ("the Act"), and of all other enabling powers, hereby makes the following Order:-

1. This Order may be cited as THE BOROUGH OF SOUTHEND-ON SEA (Off-Street Parking Places (Consolidation) Order, 2001)(AMENDMENT NO. 1 ORDER 2002) and shall come into operation on 2 April 2002, with the exception of the provisions relating to Seaway Car, Coach \& Lorry Park (as detailed in Schedule 1 No. 30 attached to this Order) which shall come into effect on 8 April 2002.
2. Items 1 and 2 of Schedule 2 of The Borough of Southend-on-Sea Off-Street Parking Places (Consolidation) Order, 2001 relating to Automatic Barrier Equipment are hereby deleted.
3. Schedule 1 of The Borough of Southend-on-Sea Off-Street Parking Places (Consolidation) Order, 2001 relating to Ticket Issuing Parking Meters is hereby amended to include Seaway and Baxter Avenue Car Parks as detailed in Schedule 1 attached to this Order and to amend the Charging Hours for the Parking Areas as detailed in Schedule 2 to this Order.
4. Schedule 5 of The Borough of Southend-on-Sea Off-Street Parking Places (Consolidation) Order, 2001 relating to Designated Bays is hereby amended as detailed in Schedule 3 attached to this Order.
5. The prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by any other enactment.
6. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
